WHEREAS, permission u/s14 Act of NCTE, 1993 was granted to the institution namely, R.G.R. Siddhanthi College of Education, D.No.703, Opp. Tivoli Gardens, Near JBS Cantonment, Secunderabad District-500003, Andhra Prdaesh run by R.G.R. Siddhanthi Educationa Society, Secunderabad District-500003, Andhra Prdaesh vide SRC (NCTE) order no.F.AP/B.Ed./New/59/SRO/NCTE/2007-2008/6569 dt.14.07.2007 for conducting Secondary B.Ed. Course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated 23.01.2015. A revised provisional recognition order was issued on 19.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 has considered the matter and the decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per the decision of SRC, a First Show Cause Notice was issued to the institution on 05.11.2019. The institution has submitted a reply on 13.01.2020.
- 4. AND WHEREAS, the SRC in its 405th meeting held on 13th 14th December 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 27.12.2021. The institution has submitted a reply on 28.01.2022.
- 5. AND WHEREAS, the SRC in its 410^{th} Meeting of SRC held on 25^{th} 26^{th} April 2022 considered the reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 28.01.2022. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has not submitted NEC.
- 2. The institution has submitted a building plan in which multi-purpose hall area is not mentioned which is a violation of clause 6(ii)(b) of Appendix 4 of NCTE Regulations, 2014.

3. The institution has not submitted a BCC in prescribed format as per NCTE Regulation 2014.

- 4. Six faculties namely, Mrs.B.Sreelatha, Mrs. D. Srilatha, Mrs.Habeeba Tabassum, Mrs. R. Santoshi, Mrs. B.Alivelu, Mrs. R. Anitha were appointed after notification (dt. 09.06.2017) of NCTE (Amendment) Regulations, 2014 and are not possessing NET/P.HD. qualification, hence, not eligible to be appointed.
- 5. The proforma of faculty is signed by the Dean and Registrar, Osmania University but the date of approval is not mentioned.
- 6. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.
- 7. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.
- 8. The institution did not submit registration certificate and bye laws of the managing society / trust.

Hence the recognition granted to R.G.R Siddhanthi College of Education, D. No 703, Opp. Tivoli Gardens, Near JBS Cantonment, Secundeabad District-500003, Telangana for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e. 2022-2023. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the academic session i.e. 2022-2023".

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to R.G.R Siddhanthi College of Education, D. No 703, Opp. Tivoli Gardens, Near JBS Cantonment, Secundeabad District-500003, Telangana run by R.G.R. Siddhanthi Educationa Society, Secunderabad District-500003, Telangana for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate counselling from the academic session i.e., 2022-2023 and the institution is also not permitted to take any fresh admission of students from the academic session 2022-2023.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University,

or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
