ORDER

In exercise of the powers vested under Section 14(3)(a) of the National Council For Teacher Education (NCTE) Act, 1993, the Southern Regional Committee grants recognition to **Adarsa College of Education, Giddalur-523357, Prakasam District, Andhra Pradesh** for **B.Ed Course** of One year duration from the academic session **2000-2001** with an annual intake of **160**, subject to fulfilling the following conditions:

1. The institution shall appoint within a period of one year one additional teaching staff possessing the academic qualifications as laid down in the NCTE norms, in the salary structure prescribed by the UGC/Central Government/State Government as the case may be.
2. All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
3. Instructor for Art & Music should be appointed.
4. Adequate accommodation for staff room and office room should be provided as per NCTE norms.
5. The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
6. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating University / State Government.
7. Tuition fee and other fees will be charged from the students as per the norms of the affiliating University / State Government till such time NCTE regulations in respect of fee structure come into force.
8. Curriculum transaction, including practical work / activities, should be organised as per the norms and standards for the course and the requirements of the affiliating University / examining body.
9. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.

10. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
  11. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The performance appraisal report should inter alia give the extent of compliance of the conditions indicated above.

If **Adarsa College of Education, Giddalur-523357, Prakasam District, Andhra Pradesh** contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfill the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.
