

ORDER

1. WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 **Nightingale Educational & Rural Development Society, 14-14, Pednalsa Bazaar, Vinukonda, Guntur District, Andhra Pradesh- 522 647** has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to **Ali College of Education, Plot No. 281/.285 , NRT Road, Vinukonda village, Guntur District- Andhra Pradesh 522 647** for conducting **B.Ed** course with an annual intake of **100** on 28.09.2010.
2. AND WHEREAS, the Inspection was conducted on 05.04.11 and VT report along with original file was placed before the Committee in its 204th Meeting held on 27th -28th April 2011. The committee considered V.T Report of the Institution and other relevant documents and decided the issue letter of Intent under 7(11) of NCTE regulations 2009 on 04.05.2011.
3. AND WHEREAS, the Institution submitted its reply to letter of Intent on 06.06.2011. Southern Regional Committee in its 206th Meeting held on 8th - 10th June 2011 considered reply of the Institution and decided to issue formal recognition
4. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to **ALI College of Education, Plot No. 281/.285, NRT Road, Vinukonda village, Guntur District- Andhr Pradesh 522 647** for conducting **B.Ed** Course of One year duration with an annual intake of 100 from the academic session **2011-12** under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject of fulfillment of the following conditions:
 - i. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or Mortgaging of FDRs shall not be done.
 - ii. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - iii. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
 - iv. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

7. Further, Southern Regional Committee in its 206th Meeting held on 9th and 10th June 2010 also resolved that the Institutions which have fulfilled all the requirements as per the norms and regulations excepting the minority certificate be directed to submit a notarized statement / undertaking
- The Institutions shall declare themselves as minority trust and minority institution proposed to be established
 - Giving an undertaking that the management shall produce valid minority certificate from the notified authority of the respective State Government on or before 31st March 2012, failing which, the Institution shall be de- recognized automatically without any further notice and that such Institutions shall make no further admission thereafter.
 - The said institute has submitted conditional minority certificate only for 2011-12 and 2012-13. As such requisite undertaking may be submitted immediately.
8. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
- (i) Copy of the Application Form
 - (ii) Land and Building Particulars
 - (iii) Staff Profile
 - (iv) Recognition letter
 - (v) Information for having fulfilled the norms & standard and other required conditions.
9. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
