**ORDER**

**WHEREAS**, recognition was granted to the institution namely **Scholars College of Education Nagavaram X Road, Wanaparthy, Mahabubnagar District-501103, Telangana** vide SRC (NCTE) order no. F.AP/NEW/B.Ed/257/SRO/NCTE/2002-2003/6722 dt. 04.04.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, thereafter the SRC vide order No. APSO 0237B.Ed./AP 2013-14/52642 dated 10.7.2013 permitted the institution to shift at new premises at Scholars College of Education, Nagavaram X Road, Wanaparthy, Mahabubnagar District, Andhra Pradesh.

3. **AND WHEREAS** on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 18.06.2015 for its willingness for adherence of provisions of new Regulations.

4. **AND WHEREAS**, a Revised Provisional Recognition Order No. F.No.SRC/NCTE/APSO0237/B.Ed/AP/2015-16/68975 was issued to the institution on 30.06.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

5. **AND WHEREAS**, subsequently the SRC issued a Corrigendum vide order dated 05.10.2015 permitting the institution to have one basis unit of 50 students.

6. **AND WHEREAS**, on the basis of request, the SRC in its 342<sup>nd</sup> meeting decided for reduction of intake from 2 units to 1 unit. Accordingly a order dated 21.7.2017 was issued.

7. **AND WHEREAS**, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

8. **AND WHEREAS** as per the decision of SRC a Show Cause Notice was issued to the institution on 11.03.2019. The institution vide letter dated 09.04.2019 & 25.06.2019 submitted reply to the show cause notice.

9. **AND WHEREAS**, the matter was finally considered by the SRC in its 377<sup>th</sup> meeting held on 03<sup>rd</sup> – 04<sup>th</sup> July, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply furnished by the institution The Committee decided that Order for Continuance of recognition of B.Ed. course with an annual intake of 100 of two basic units, (50 students each unit) be issued to the institution.

10. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Scholars College of Education, Sy. No. 30,31,32,29,38&175, Nagavaram (Village), Wanaparthy (Mandal), Mahabubnagar (Dist), Telangana State-509103** run by **Scholars Educational Society Nagavaram 'X' Road – Nagavaram (Village) Wanaparthy (Mandal), Mahabubnagar (Dist) Telangana State-509103** for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (two units of 50 each) subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

12. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter;
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.

16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
