WHEREAS, recognition was granted to the institution namely J.S.S College of Education, Vidyagiri, Dharwad-580004, Karnataka run by Janata Shikshana Samiti. Dharwad District - 580004, Karnataka vide SRC (NCTE) order No. F.SRO/NCTE/B.Ed/2006-2007/7750 dated 10.8.2007 for conducting Secondary (B.Ed) course of one year duration with annual intake of 100 students.

AND WHEREAS, on 30.01.2015, the institution submitted the affidavit for offering B.Ed course with an intake of 100 students. Accordingly, a Revised Order was issued to the institution for conducting B.Ed programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 on 31.05.2015.

AND WHEREAS, on 31.03.2015, the institution submitted a letter regarding request for changing the nomenclature of our JSS College of Education into JSS Shri Manjunatheshwara College of Education, Dharwad.

AND WHEREAS, the SRC in its 284th meeting held during 09th - 10th April, 2015 considered the request of the institution and decided to process. Accordingly, the application was processed. The request for change of name of the institution was considered and agreed. Accordingly, a corrigendum was issued to the institution on 21.07.2015 for change of name of the institution as JSS Sri Manjunatheshwara College of Education, Vidyagiri, Dharwad-580004, Karnataka The institution has submitted revised order reply on 03.11.2015, 02.03.2016, 26.05.2016, 28.5.2018.

AND WHEREAS, SRC in its 314th meeting held during 27th to 28th May 2016 considered the matter of institution which have been given recognition for offering with an intake of 100 students and authorized the RD to initiate VT inspection accordingly. As per the decision of SRC, a letter to the institution was issued on 13.06.2016. The institution submitted inspection fees of Rs. 1,50,000/- vide DD No - 557834 dated 04.07.2016. Accordingly, Inspection of the institution was conducted on 21.10.2016 and the VT report along with documents received on 24.10.2016.

AND WHEREAS, the SRC in its 351st meeting held during 28th - 29th December, 2017considered the VT report and the decision of SRC Show Cause Notice was issue to the The institution has submitted Show Cause Notice reply on institution on 05.01.2018. 30.01.2018, 01.02.2018, 03.05.2018 & 16.01.2019.

AND WHEREAS, the SRC, in its 376<sup>th</sup> meeting held during 11<sup>th</sup> -12 June, 2019 consider the request and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to issue **Show Cause Notice u/s 17 of NCTE Act**, 1993 before withdrawal of the recognition on the following grounds:-

"Latest Staff list duly approved by the affiliating university as per the prescribed Format"

AND WHEREAS, as per the decision of SRC, a show cause notice was issued to the institution on 18.06.2019. The institution vide letter dated 09.07.2019 submitted reply to the show cause notice enclosing therewith a staff list approved by the Registrar, Karnataka University, Dharwad.

**AND WHEREAS,** the matter was finally considered by the SRC in its 378<sup>th</sup> meeting held from 25<sup>th</sup> & 26<sup>th</sup> July, 2019 decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On perusal of the response received to our show cause notice and decided to continue the recognition to J.S.S. Sri. Manjunatheshwara College of Education, Vidyagiri, Dharwad-580004, Karnataka for B.Ed programme for 2 units (50 students each)".

NOW THEREFORE, this order is issued permitting the institution JSS Sri Manjunatheshwara College of Education, RS No.1A/1 of Lakhamanahalli Village Dharwad, Ward No.20, Lakhamanahalli Village Vidyagiri, Hubli-Dharwad-580004, Karnataka run by Janata Shikshana Samiti Dharwad District — 580004, Karnataka for continuation of conducting B.Ed course of two years duration with an intake of 100 students (two basic units) subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 7. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with

photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

a. Sanctioned programme(s) along with annual intake in the institution:

b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

c. Name of faculty members who left of joined during the last, quarter:

d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e. Fee charged from students;

f. Available infrastructural facilities;

g. Facilities added during the last quarter; h. Number of books in the library, journals subscribed to and additions, if any, in the last

The affidavit with enclosure submitted along with application.

The institution shall be free to post additional relevant information, if it so desires.

- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

The institution shall make available the list of students admitted on its official website.

The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993. Also order that a copy of this Order be published in the official Gazette.
