WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely Varma College of Education, Plot/Khasra No. 1133, Gajulamandyam Village, Renigunta Post Office, Tirupati Taluk & Town, Chittoor District, Andhra Pradesh-517520 run by Varma Educational Academy, Plot No. 534, Reddy & Reddy Colony, Tirupati Village & Post Office, Tirupati Taluk & City, Chittoor District-517501, Andhra Pradesh vide order no. F.SRO/SRCAPP2677/B.Ed./AP/2017-18/85928 dated 07.06.2016 for conducting B.Ed. programme of two years duration with one unit of 50 students from the academic session 2017-2018.

- 2. AND WHEREAS, the SRC in its 408<sup>th</sup> Meeting held on 02<sup>nd</sup> March, 2022 taken the decision to issue Show Cause Notice to all the colleges to teacher education established even after NCTE Regulations, 2014 at the earliest in order to ascertain the compliance of NCTE Regulations, 2014. Accordingly, as per decision of SRC Show Cause Notice was issued on 01.08.2022. The institution has not submitted reply to the Show Cause Notice.
- 3. AND WHEREAS, the SRC in its  $413^{th}$  meeting held on  $22^{nd} 23^{rd}$  August, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 05.09.2022. The institution has submitted reply it self on 05.09.2022.
- **4. AND WHEREAS**, the SRC in its 414<sup>th</sup> Meeting held on 26<sup>th</sup> 27<sup>th</sup> September, 2022 considered the matter and decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Varma College of Education, Survey No. 1133/1, Gajulamandyam, Renigunta Mandal, Chittoor District, Andhra Pradesh-517520 for B.Ed. programme for 1 basic unit of 50 students.

- 5. NOW THEREFORE, this order is issued permitting the institution i.e., Varma College of Education, Survey No. 1133/1, Gajulamandyam, Renigunta Mandal, Chittoor District, Andhra Pradesh-517520 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:-
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, guarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.
  - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
