WITHDRAWAL ORDER

WHEREAS, recognition u/s14(3)(a) of NCTE Act, 1993 was granted to the institution namely, J.J. College of Physical Education, J.J. Nagar, Sivapuram, Namanasamudram Post, Pudukkottai District-622404, TamilNadu run by Karpaga Vinayaga Educational Trust, Pudukottai District, TamilNadu vide SRC (NCTE) Order No. F.SRO/NCTE/B.P.Ed. /2006-2007/221 dated 09.04.2008 for conducting B.P.Ed. Course of one year duration with an annual intake of 50 students.

- AND WHEREAS, the SRC in its 294th meeting held on 14th 16th November 2015 has considered the matter and decided to issue a Show Cause Notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 20.05.2016.
- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated 30.05.2016.
- AND WHEREAS, the SRC in its 319th meeting held on 30th 31st August 2016 and decided as under:-
 - Affidavit has now been received.
 - There is no point in issuing an RPRO at this stage. The college by their delayed submission of affidavit is responsible for this situation.
 - They want to operate a one-year B.P.Ed. course with 50 students. The new Regulations recognize only a two-year B.P.Ed. Course with a basic unit of 100 students.
 - Issue SCN accordingly.

Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 29.09.2016.

AND WHEREAS, the SRC in its 404th meeting held on 16th - 17th November 2021 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to

the institution on 30.11.2021. The management of the institution has not submitted a reply to the Final Show Cause Notice till the date.

6. AND WHEREAS, the SRC in its 415^{th} Meeting of SRC held on $03^{rd}-04^{th}$ November 2022 considered the matter for non-submission of reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- (i) The institution failed to submit reply to the Final Show Cause Notice dated 30.11.2021.
- (ii) The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

Hence the recognition granted to J.J. College of Physical Education, J.J. Nagar, Sivapuram, Namanasamudram Post, Pudukkottai District-622404, TamilNadu for B.P.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn".

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to J.J. College of Physical Education, J.J. Nagar, Sivapuram, Namanasamudram Post, Pudukkottai District-622404, TamilNadu for conducting B.P.Ed. Programme of one year duration with an annual intake of 50 students with effect from the end of next academic session i.e., 2023-2024.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school,

College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
