WHEREAS, the recognition u/s 14(3)(a) of NCTE Act,1993 was granted to the institution namely Sri Vasavi Raja Prathap College of Elementary School Education, H.N. 1-1085/3/C, S.S. Gutta, Christian Pally, New Town, Mahabubnagar District-509001, Andhra Pradesh run by Rajavaram Educational Society, Mahabubnagar District, Andhra Pradesh vide order no F.SRO/NCTE/D.Ed./2008-09/6689 dated 05.11.2008 for conducting D.Ed. course of two-years duration with an annual intake of 50 students.

- 2. AND WHEREAS, the SRC in its 344<sup>th</sup> meeting held on 17<sup>th</sup> 18<sup>th</sup> August, 2017 considered the matter and decided to permit shifting of premises from Sri Vasavi Raja Prathap of Elementary Education H.No.1-10-85/3C, S.S. Gutta ChristianPally, New Town Mahabubnagar Dist-509001, Andhra Pradesh to Sri Vasavi Raja Prathap College of Education and Elementary School Education, Sy.No.130/B, 131/A, 5-139, Pillamarri Road, Dodalonipally (V), H/o Boyapally, Mahabubnagar (M & Dist), Telangana.
- 3. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct and 01st, Nov, 2019 considered the matter and decided to issue First SCN in all such matters where the institution has not submitted requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC including B.Ed. programme. Accordingly, a First Show Cause Notice was issued to the institution on 21.11.2019. The management of the institution submitted its reply to the first SCN vide letter dated 07.12.2019.
- **4. AND WHEREAS,** the SRC in its 409<sup>th</sup> meeting held on 29<sup>th</sup> and 30<sup>th</sup> March 2022 considered the matter and committee decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 08.04.2022. The institution has submitted reply of FSCN vide letter dated 14.05.2022.
- 5. AND WHEREAS, the SRC in its 415<sup>th</sup> Meeting held on 03<sup>rd</sup> and 04<sup>th</sup> November 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

(i) The institution failed to submit reply to the Final Show Cause Notice dated 18.04.2022.

(ii) The Committee further noted that the institution has not filled Performance Appraisal Report (PAR) for the D.Ed. course which is mandatory as per NCTE Regulation 2014.

Hence the recognition granted Sri Vasavi Raja Prathap College of Elementary School Education, Sy.No. 130/B, 131/A, Pillamarri Road, Dodalonipally (V), H/o Boyapally, Mahabubnagar (M & Dist), Telangana for D.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn."

- 6. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sri Vasavi Raja Prathap College of Elementary School Education, Sy.No. 130/B, 131/A, Pillamarri Road, Dodalonipally (V), H/o Boyapally, Mahabubnagar (M & Dist), Telangana run by Rajavaram Educational Society, Mahabubnagar District-509001, Telangana for conducting D.El.Ed. programme of two-year duration with an annual intake of 50 students from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है, या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार व्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")
