WHEREAS, the recognition u/s 14 (3) (a) of NCTE Act. 1993 was granted to the institution namely Gokul college of Education, Gokul Nagar Colony, Nalgonda District-508001, Andhra Pradesh vide order no F.AP/B.Ed/36/SRO/NCTE/2000-2001/1274 dated 19.07.2000 for conducting B.Ed. course of one-year duration with an annual intake of 160 students from the academic session 2000-2001.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order (RPRO) was issued to the institution on 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, a Corrigendum was issued to the institution vide order no. F.SRO/NCTE/AOSO0192/B.Ed./AP/2015/68260 dated 24.06.2015 with an annual intake of 150 for three basic units from the academic session 2015-16.
- 4. AND WHEREAS, the SRC in 388th meeting held on 14th 15th 2020 considered the matter and decided that SCN issued to all such institutions which have not submitted compliance in RPRO matter. Accordingly, A Show Cause Notice was issued to the institution on 13.04.2021. The institution has not submitted reply to the Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 406th meeting held on 19th January 2022 has considered the matter and decided to issue Final Show cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 04.02.2022. The institution has submitted its reply on 25.02.2022 and 15.03.2022.
- **6. AND WHEREAS,** the SRC in its 414th meeting held on $26^{th} 27^{th}$ September 2022 has considered the matter and decided to issue a Last Reminder Letter. Accordingly, as per the decision of SRC, a Last Reminder Letter was issued to the institution on 12.10.2022. The institution vide letter dated 21.10.2022 has submitted a reply to the Last Reminder Letter.
- 7. **AND WHEREAS**, the SRC in its 415th Meeting held on 03rd & 04th November 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee noted that the provisional revised recognition order dated 26.05.2015 was issued by the SRC to the institution for conducting B.Ed. programme of two years

duration with an annual intake of 100 students for two basic units i.e., 50 students each from the academic session 2015-16. Thereafter a corrigendum dated 24.06.2015 was issued by the SRC whereby the annual intake from two basic units was enhanced to three basic units.

The institution was issued a Last Reminder Letter. The institution has submitted its reply vide letter dated 21.10.2022. The Committee perused the reply submitted by the institution and found the following deficiencies.

- 1. A photocopy of faculty list approved by Registrar, Mahatma Gandhi University consisting of one Principal and 15 Lecturers vide dated 10.03.2022 are not sufficient for three basic units as per NCTE Regulation 2014.
- 2. Two Assistant Professor namely, Sh. T Srinivas and Sh. G Rambabu does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017.
- 3. The institution has not appointed faculty in Performing Arts.
- 4. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account except the photocopy of cheques for the month of September 2022 only.

Hence the recognition granted to **Gokul College of Education**, **Gokul Nagar Colony**, **Nalgonda District-508001**, **Telangana** for **B.Ed. course** is withdrawn under Section 17(1) of NCTE Act, 1993 from the academic year **2023-2024**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn."

- 8. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Gokul College of Education, Gokul Nagar Colony, Nalgonda District-508001, Telangana run by Gokul Educational Society, Nalgonda, Telangana for conducting B.Ed. programme of two-year duration with an annual intake of 150 students (three basic units) for B.Ed. Programme is withdrawn under Section 17(1) of NCTE Act, 1993 from the academic year 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn.
- 9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमित प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

- 10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
