WITHDRAWAL ORDER

WHEREAS, recognition u/s14(3)(a) of NCTE Act, 1993 was granted to the institution namely, Madasu Bhukailasam College of Education, Sy No. 543, Chitukal Village and Post Office, Patancheru Taluka, Medal District-506167, Telangana run by Dharani Educational Society, Plot No.1-3-90/C, Geetha Nagar Village, Jangoan Post Office and Taluk, Warangal District-506167, Telangana vide SRC (NCTE) Order No. F.SRO/SRCAPP1201/D.El.Ed/AP/2015/62257 dated 03.03.2015 for conducting D.El.Ed. Course of two years duration with an annual intake of 50 students from the academic session 2015-2016.

- 2. AND WHEREAS, the SRC in its 412^{th} meeting held on $05^{th}-06^{th}$ July 2022 took note about non-functioning of the website of the institutions which is mandatory requirement as per NCTE Regulations, 2014. In view of the non-compliance, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institution seeking infrastructure and instructional details along with GIS location at the earliest. As per decision of SRC, Show Cause Notice was issued to the institution on 03.08.2022. The management of the institution did not submit any reply to the Show Cause Notice.
- 3. AND WHEREAS, the SRC in its 413th meeting held on 22nd 23rd August 2022 the Committee discussed in detail about the institutions who failed to submit the PAR as advised by the NCTE. The Regional Director, SRC jurisdictional area and serve a Show Cause Notice for failure of submitting the PAR to all such institutions seeking infrastructural & instructional details along with GIS location etc. If any institution failed to respond to Show Cause Notice for compliance, after completion of given time, the RD, SRC may issue Final Show Cause Notice and place before the Committee for appropriate action. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 08.09.2022. The management of the institution has not submitted the reply of Final Show Cause Notice till the date.
- **4. AND WHEREAS,** the SRC in its 415^{th} Meeting of SRC held on $03^{rd}-04^{th}$ November 2022 considered the matter for non-submission of reply to Final Show Cause Notice and decided as under: -

time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- (i) The institution failed to submit reply to the Final Show Cause Notice dated 08.09.2022.
- (ii) <u>Further it is also observed that the institution has not filled</u> Performance Appraisal Report (PAR)

Hence the recognition granted Madasu Bhukailasam College of Education, Sy No. 543, Chitukal Village and Post Office, Patancheru Taluka, Medal District-506167, Telangana for D.El.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting".

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Madasu Bhukailasam College of Education, Sy No. 543, Chitukal Village and Post Office, Patancheru Taluka, Medal District-506167, Telangana for conducting D.El.Ed. Programme of two years duration with an annual intake of 50 students (one unit) with effect from the end of next academic session i.e., 2023-2024.
- **6.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school,



College or other Educational Body aided by the Central Government or any State Government."

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
