**ORDER**

WHEREAS, the institution namely **Huliyappa Malamma B.Ed. College, 24/1, Chikkajala, Chikkanahalli, Bangalore North, Anandanagar, Bangalore-560057, Karnataka** was granted recognition for conducting (B.Ed.) course of one-year duration with an annual intake of 100 students vide SRC, NCTE's vide order no. F.SRO/NCTE/B.Ed./2004-2005/9056 on dt.02.12.2004.

AND WHEREAS, the Tamilnadu Teachers Education University had forwarded a copy of show cause notice issued to the institution for not functioning in accordance with the conditions stipulated by the NCTE, SRC, Bangalore and Tamilnadu Teachers Education University as could be apprehended from the report of Inspection commission which caused a surprise visit to the colleges.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 23.03.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 20.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 for two basic units of 50 students from the academic session 2015-2016 with a condition to maintain.

AND WHEREAS, the matter was placed before in 314<sup>th</sup> meeting of SRC held on 27<sup>th</sup> & 28<sup>th</sup> May, 2016 wherein a general decision was taken to cause inspection of such cases. Accordingly, as per the decision of SRC, a letter for inspection was sent on 13.06.2016 and the inspection was not conducted. On 28.06.2016, the institution has submitted a request letter to run the B.Ed. programme with a single unit with an annual intake of 50 students.

AND WHEREAS, the SRC in its 329<sup>th</sup> meeting held on 06<sup>th</sup> - 07<sup>th</sup> February, 2017 considered the request of the institution for one unit and decided as a letter was issued to the institution. As per the decision of SRC a letter was issued to the institution vide dated 13.02.2017. On 23.01.2018, a letter received by this office from the advocate along with copy of the writ petition no.54843/2017 and court order dated 12.12.2017.

AND WHEREAS, the matter was placed before the SRC in its 381<sup>st</sup> meeting held on 22<sup>nd</sup> October, 2019. The Sub-Committee noted the institutions have not submitted requisite documents or only part reply has been submitted. The Sub-Committee decided to issue SCN. As per the decision of SRC a Show Cause Notice was issued to the institution vide dated 04.11.2019 the institution has submitted its reply along with documents vide letter dated 25.11.2019.

AND WHEREAS, the matter was placed before the SRC in its 383<sup>rd</sup> meeting held on 07<sup>th</sup> – 09<sup>th</sup> January, 2020 considered and decided as under:

**"The Committee decided to constitute the Visiting Team for inspection of infrastructure & instructional facilities etc. for shifting of premises of Huliappa Malamma B.Ed College, Anandanagar, Bangalore- 560024, Karnataka for the B.Ed course after collecting a fee of Rs 1,50,000/-"**

AND WHEREAS, as per the decision of SRC a letter was issued to the institution vide dated 15.01.2020. As per the direction of SRC, the inspection was conducted on 18.12.2020 and 19.12.2020 and the VT Report received in the office of SRC on 30.12.2020.

AND WHEREAS, the matter was placed before the SRC in its 393<sup>rd</sup> meeting held on 5<sup>th</sup> – 6<sup>th</sup> January, 2021 considered and decided as the following grounds:

**"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -**

The Committee on the perusal of the reply submitted by the institution, the Committee decided that the **continuation order** be issued to the Institution **Huliappa Malamma B.Ed College, Anandanagar, Bangalore 560024, Karnataka for B.Ed programme for 2 basic units of (50 students each unit)**. In addition to the above, the **Shifting of premises of the institution to its own new permanent building is also hereby permitted."**

NOW THEREFORE, this order is issued permitting the institution i.e. **Huliappa Malamma B.Ed. College, 24/1, Chikkajala, Chikkanahalli, Bangalore North, Anandanagar, Bangalore-560057, Karnataka** for continuation of recognition for B.Ed programme for 2 basic units of (50 students each unit) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
1. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.
  2. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
  3. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
    - a. Sanctioned programme(s) along with annual intake in the institution;
    - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
    - c. Name of faculty members who left or joined during the last, quarter;
    - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
    - e. Fee charged from students;
    - f. Available infrastructural facilities;
    - g. Facilities added during the last quarter;
    - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
    - i. The affidavit with enclosure submitted along with application.
    - j. The institution shall be free to post additional relevant information, if it so desires.
    - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
  4. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
  5. The institution shall make available the list of students admitted on its official website.
  6. The institution shall fill the information on GIS Portal on the NCTE Website.

:4:

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
