WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution namely, **Avinashilingam Institute For Home Science and Higher Education for Women, S.A.H.S. College, Coimbatore, Tamilnadu-641043** run by **Avinashilingam Institute for Women Science and Higher Education for Women, Bharathi Park Road, Coimbatore, Tamilnadu** for conducting **M.Ed.** course of one-year duration with an annual intake of 25 students.

2. **AND WHEREAS**, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to **Avinashilingam Institute For Home Science and Higher Education for Women, S.A.H.S. College, Coimbatore, Tamilnadu-641043** vide order No. F.SRO/NCTE/2010-2011/20637 dt. 24.08.2010 from the session 2010-2011.

3. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 24.02.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.05.2015 for conducting **M.Ed. programme** of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-2016.

6. **AND WHEREAS**, the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the both courses and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 03.11.2021. The institution has submitted reply on 22.11.2021.

7. **AND WHEREAS**, the SRC in its 405th Meeting held on 13th & 14th December, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 22.11.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted Building plan in which Multipurpose Hall area is not match with Building Completion Certificate.*
- 2. The institution has submitted Land Use Certificate which is not in prescribed format of NCTE Regulation.*
- 3. The institution submitted a proforma of 16 faculty for B.Ed. course signed by the Registrar, Avinashlingam Institute for Home Sciences and Higher Education for Women (University) but the date of approval is not mentioned. The proforma further shows the appointment of 12 faculty on contract and guest faculty which is against the requirement laid down under Appendix 4 of NCTE Regulations, 2014.*

4. The institution submitted a proforma of 10 faculty for M.Ed. course signed by the Registrar, Avinashlingam Institute for Home Sciences and Higher Education for Women (University) but the date of approval is not mentioned. The date of joining of faculty is not mentioned in the proforma. Further, only one professor has been appointed against the requirement of two. The proforma further shows the appointment of 05 faculty on contract and guest faculty which is against the requirement laid down under Appendix 5 of NCTE Regulations, 2014.
5. The institution submitted a proforma of 14 faculty for B.P.Ed. course signed by the Registrar, Avinashlingam Institute for Home Sciences and Higher Education for Women (University) but the date of approval is not mentioned. The date of joining of faculty is not mentioned in the proforma. The proforma further shows the appointment of 11 faculty on contract and guest faculty which is against the requirement laid down under NCTE Regulations, 2014.

Hence, the Committee decided to **withdraw the recognition granted to Avinashlingam Institute for Home Science and Higher Education for Women, Deemed University, Coimbatore-641043, Tamilnadu for conducting B.Ed., M.Ed. & B.P.Ed. programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.**"

8. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Avinashlingam Institute for Home Science and Higher Education for Women, Deemed University, Coimbatore-641043, Tamilnadu run by Avinashlingam Institute for Women Science and Higher Education for Women, Bharathi Park Road, Coimbatore, Tamilnadu for conducting M.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) with effect from the academic session i.e., 2022-2023 onwards.**

9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
