WHEREAS, the recognition was granted to the institution namely, Sri Kannika Parameshwari Education Foundation D.Ed. College, Kakatiya Colony, Behind K.E.B. Quarters, Lingasugur Road, Raichur, Karnataka-584101 run by Sri Kannika Parameshwari Education Foundation, Raichur, Karnataka vide SRC vide order no. F.SRO/NCTE/D.Ed./2004-2005/8742 dt. 29.11.2004 for conducting Elementary (D.Ed.) course of two and half year's duration from the academic session 2004-05 with an annual intake of 50 students.

AND WHEREAS, the institution vide letter dated 12.11.2021 has submitted request to close the D.Ed. Programme. The SRC in its 405th Meeting held on 13th & 14th December 2021 considered the request for close the D.Ed. Programme matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the institution vide letter dated 12.11.2021 by withdrawing the recognition granted to Sri Kannika Parameshwari Education Foundation D.Ed. College, Near Little Angles School, Eklaspur Road, Lingasugur Road, Raichur-584101, Karnataka for conducting D.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director."

- **NOW THEREFORE.** in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993. the Southern Regional Committee hereby withdraws recognition granted to Sri Kannika Parameshwari Education Foundation D.Ed. College, Near Little Angles School, Eklaspur Road, Lingasugur Road, Raichur-584101, Karnataka for conducting D.Ed. programme of two and half years duration with an annual intake of 50 students (1 basic unit) with effect from the academic session i.e., 2021-2022 onwards.
- 4. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or

training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

**5.** Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order.
