"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

In Compliance of order dated 03.12.2021 passed Hon'ble High Court of Delhi W.P (C) No. 13675/2021 titled as BTL College of Education Versus NCTE& others, the committee had decided has under:-

In Compliance of order dated 03.12.2021, the Regional Director has issued order dated 06.12.2021, the committee confirms the said order.

The Committee further decided to issue order for withdrawal of the recognition to B.T.L. College of Education, No. 259/B, Bommasandra Industrial Area, Hosur Main Road, Bangalore – 560099, Karnataka stands effective from the academic session 2022-23.

The Regional Director, SRC is advised to issue modification / corrigendum to withdrawal order in this regard".

NOW THEREFORE, the decision in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, communicated vide order No. No.F.SRO/NCTE/APS03719/B.Ed./KA/2021/128753 dated 07.10.2021 based on the decision of SRC taken in 402th meeting held on 13th – 14th September 2021 may be read as the Southern Regional Committee hereby withdraws recognition granted to B.T.L. College of Education, No. 259/B, Bommasandra Industrial Area, Hosur Main Road, Bangalore – 560099, Karnataka for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units 50 students each) w.e.f. the academic session i.e., 2022-2023 onwards instead of academic session 2021-2022.

Other contents of order No. F.SRO/NCTE/APS03719/B.Ed./KA/2021/128753 dated 07.10.2021 shall remain unchanged.
