WHEREAS, the recognition was granted to the institution namely, Shri. Siddhivinayaka Rural P.G. M.Ed. College, Harugeri, Raibag, Belgaum District, Karnataka-591220 run by Shri S. S. Jambagi Memorial Education and Charitable Trust, Karnataka -581220 vide SRC vide order no. F.SRO/NCTE/M.Ed./2009-2010/18241 dt. 07.04.2010 for conducting M.Ed. course of one-year duration with an annual intake of 25 students from the academic session 2010-2011.

- 2. AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to Shri. Siddhivinayaka Rural P.G. M.Ed. College, Harugeri, Raibag, Belgaum District, Karnataka-591220 vide order No. F.SRO/NCTE/2010-2011/20637 dt. 24.08.2010 from the session 2010-2011.
- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has 3. submitted affidavit dated 20.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 26.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-2016.
- AND WHEREAS, the SRC in its 369th Meeting held on 28th January 2019 considered the matter and decided to issue another SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the regional Committee. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 14.02.2019. The institution did not submit reply to the Show Cause Notice.
- AND WHEREAS, the matter was further considered by the Sub-Committee constituted by the SRC as per its decision taken in 380th Meeting. The Sub-Committee of the SRC decided to issue Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 15.10.2019. The institution vide letter dated 06.03.2020 requested for closure of the M.Ed. Programme.
- AND WHEREAS, the SRC in its 405th Meeting held on 13th & 14th December, 2021 considered the request for closure of the M.Ed. Programme matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

Siddhivinayaka Rural P.G. M.Ed. College, Harugeri, Raibag, Belgaum District, Karnataka-591220** for conducting **M.Ed. Programme** under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Shri. Siddhivinayaka Rural P.G. M.Ed. College, Harugeri, Raibag, Belgaum District, Karnataka-591220 run by Shri S. S. Jambagi Memorial Education and Charitable Trust, Karnataka -581220 for conducting M.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) with effect from the academic session i.e., 2021-2022 onwards.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
