**WITHDRAWAL ORDER**

**WHEREAS**, the institution namely **Amritalaya Teacher Training Institute, Chinnamottoor Village, Kethandapatti Sugar Mill Post, Tirupattur Taluk, Vellore District, Tamilnadu-635601** was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/D.T.Ed./2006-2007/8354 dt. 06.10.2006 for conducting D.T.Ed. course of two years duration with an annual intake of 50 students from the academic session 2006-2007 on rented premises with condition that the institution would shift their institution to its own/permanent building within 3 years.

**AND WHEREAS**, the matter was placed before the SRC in its 181<sup>st</sup> meeting held on 31<sup>st</sup> October -01<sup>st</sup> November 2009 considered the matter and decided to issue Show Cause Notice to such institution which are running on Rented premises and have not shifted to own permanent building even after stipulated time period of 3 years.

**AND WHEREAS**, a Show Cause Notice was issued to the institution vide dt. 14.09.2009.

**AND WHEREAS**, the institution has submitted a fee for inspection of shifting of Rs. 40,000/- for inspection but not submitted required documents for shifting premise.

**AND WHEREAS**, the matter was further considered by the SRC meeting 387<sup>th</sup> held on 24<sup>th</sup> -25<sup>th</sup> August 2020 and committee decided to issue Final Show Cause Notice.

**AND WHEREAS**, after that a Final Show Cause Notice was issued to the institution on dated 01-09-2020 but institution has not submitted any reply/documents against Final Show Cause Notice till date.

**AND WHEREAS**, the SRC in its 393<sup>rd</sup> Meeting held on 05<sup>th</sup> & 06<sup>th</sup> January 2021 and considered the matter as under: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1. The management has not shifted its institution to its own permanent building, which is a **violation of the NCTE Regulations 2002, 3(c)**. The institution is required to clarify the same.
2. The institution has not submitted any representation to the Final Show Cause Notice issued to the institution on 01.09.2020.

**NOW THEREFORE**, the Committee decided to **withdraw the recognition** granted to **Amritalaya Teacher Training Institute, Chinnamottoor Village, Kethandapatti Sugar Mill Post, Tirupattur Taluk, Vellore District, Tamilnadu-635601** for conducting **D.T.Ed** course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org), with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
