WITHDRAWAL ORDER

WHEREAS the institution namely Dr. Nagarathinam's Teacher Training Institute, No. 52/7, Seelanaickanpatti Village, Salem, Tamilnadu-636201 was granted recognition vide SRC (NCTE) order no. F.TN//NCTE/D.T.Ed./2006-2007/8989 dated 08.11.2006 for conducting D.T.Ed. course of one year' duration with an annual intake of 50 students.

AND WHEREAS, the SRC in its 209th Meeting held on 31st July 2011 considered the DTERT complaint dt. 25.07.2011 and all the relevant documentary evidence and it was decided to serve Show Cause Notice under section 17 of NCTE Act for the following: -

- 1. On perusal of the report the institute is functioning in a rental building consists of two rooms only and the rooms do not have proper ventilation.
- 2. A matriculation School is also functioning in the same campus.
- 3. The institute has not been provided laboratory and Library facilities and other mandatory requirements for the students.
- 4. Three years period has already been lapsed.
- 5. The Management of the institute is not ready to shift the institute to its own building.
- 6. The institute has no adequate teaching staff for students as per NCTE norms.
- 7. Thus, the management of the institute has violated the Regulations, Norms and Standards of the NCTE.

AND WHEREAS, as per decision a Show Cause Notice was issued to the institution on dt. 30.09.211.

AND WHEREAS, the SRC in its 213rd Meeting held on 06th & 07th November 2011 considered the VT Report, and all the relevant documentary evidences and decided to serve Show Cause Notice under Section 17 of NCTE Act. Accordingly, a Show Cause Notice was issued to the institution on dt. 19.12.2011. The institution had submitted its written representation on 09.01.2012.

AND WHEREAS, the SRC in its 217th Meeting held on 08th & 09th February 2012 considered the reply of the institution dt. 09.01.2012, VT Report, VCD and all the relevant documentary evidence and decided to serve Final Show Cause Notice under Section 17 of NCTE Act.

AND WHEREAS, a Final Show Cause Notice was issued to the institution on 08.03.2012. The institution had submitted its written representation on dt. 30.03.2012.

AND WHEREAS, SRC in its 229th Meeting held on 30-31st July 2012, considered the reply of the institution on dt. 30.03.2012 and other related documents along with the original file of the institution for shifting to new/permanent premises and decided to permit shifting of D.T.Ed. course only to new premises under intimation to the Affiliating body.

AND WHEREAS, permission is hereby accorded by the SRC to Dr. Nagarathinam's Teacher Training Institute, No. 52/7, Seelanaickanpatti Village, Salem, Tamilandu-636201 to shift its premises to the new location/building at Dr. Nagarathinam's, 31/1B, Ananthagoundampalyam Village, Minnakal Post, Rasipuram Taluk, Namakkal District, Tamilandu vide order no. F.No. APSO5016/D.T.Ed./TN/2012-13/45659 of dt.29.08.2012.

AND WHEREAS, the institution has submitted a written reply on dt. 08.07.2019 & 05.01.2021 as under: -

"With reference to the above cited subject matter under reference, Our Dr. Nagarathinam's Teacher Training Institute, 52/7, Seelanaikanpatty Village, Salem, Tamilandu-636201 under run by Chandramohan Nagarathinam Charitable Trust 432, Trichy Main Road, Gugai, Salem, Tamilandu-636006 due to No Admission from 2012 onward, we are closing our Dr. Nagarathinam's Teacher Training Institute."

AND WHEREAS, the SRC in its 393rd Meeting held on 05th & 06th January 2021 and considered the matter as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee decided to withdraw the recognition granted to Dr. Nagarathinam's 31/1B Ananthagaoundampalyam Village, Minnakal Post, Rasipuram Taluk, Namakkal District, Tamil Nadu 637505 for conducting D.T.Ed course under clause 17(1) of NCTE Act, 1993 on its own request made by the institution. However, the FDRs towards Reserve Fund and Endowment Fund/No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course."

NOW THEREFORE, the Committee decided to withdraw the recognition granted to Dr. Nagarathinam's 31/1B Ananthagaoundampalyam Village, Minnakal Post, Rasipuram Taluk, Namakkal District, Tamil Nadu 637505 for conducting D.T.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
