WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely **Kumari Monika Basavaraj Kanni B.Ed. College, Opp. AI-Ameen Medical College, Anthani Road, Navarsapur, Bijapur District-586101, Karnataka** run by **Sri Siddalingeshwar Vidyavardhak Sangh, Bijapur District, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/15695 dt. 06.12.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 02.02.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 18.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the Southern Regional Committee in its 298th Meeting held during 08th to 10th January 2016 considered the matter; letter dt. 30.07.2015 from the institution and decided to conduct inspection. Thereafter, on 28.01.2015 the institution has submitted a request for postponement of inspection. The matter was placed before the SRC in its 309th Meeting held on 12th to 14th April 2016. The SRC Committee considered the matter and decided to cause inspection after a month. Accordingly, as per directed, a letter was issued on 14.06.2016 to the institution for conducting inspection. Till date no inspection has been conducted.

AND WHEREAS, the SRC in its 374th Meeting held during 09th & 10th April 2019 considered the matter and decided to issue Show Cause Notice. As per decision a Show Cause Notice was issued to the institution on dt. 25.04.2019. The institution has not submitted its reply till date. the SRC in its 381st Meeting held on 31st October & 01st November 2019 & 387th Meeting held on 24th & 25th August 2020 the matter was considered the matter and decided to issue the Final Show Cause Notice and the Final Show Cause Notice was issued to the institution on dt. 09.09.2020. the institution has submitted its reply on 13.10.2020.

AND WHEREAS, the SRC in its 393rd meeting held on 5th-6th January 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the reply submitted by the institution on 13.10.2020 in respect to the Final Show Cause Notice and found the following deficiencies: -

- 1. The institution was granted recognition initially in a rented premise with a condition to shift to its owned permanent building within a period of 3 years as evident from visiting team reports dated 28.06.2007. A show cause notice dt 25.04.2019 followed by Final Show Cause notice dt 09.09.2020 were issued to the institution to submit the compliance, but in its representation dt 08.10.2020 the institution is seeking extension of six months' time to collect the necessary documents pertaining to the building and owned building. Further, the Lease Deed is stated*

that have been expired on 31.05.2020 and the institution has moved to the new building on 01.06.2020.

2. The institution has not submitted certified copy of registered land along with the notarized English translated version of the same. The RTC submitted by the institution is in regional language.
3. The institution has not submitted Form A issued by concerned Branch manager towards creation of Endowment and Reserve fund as per NCTE Regulations, 2014.
4. The institution has not submitted original blue prints of the Building Plan and Site Plan duly approved by the competent authority.
5. The institution has not submitted Land Use Certificate, Building Completion Certificate & Latest Encumbrance Certificate duly approved by the competent authority.
6. The institution has also not submitted latest staff list in prescribed format duly signed by the Registrar, of concerned affiliating body.

Hence, the Committee decided to **withdraw the recognition** granted to **Kumari Monika Basavaraj Kanni B.Ed. College, Opp. AI-Ameen Medical College, Anthani Road, Navarsapur, Bijapur District-586101, Karnataka** for conducting **B.Ed** course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Kumari Monika Basavaraj Kanni B.Ed. College, Opp. AI-Ameen Medical College, Anthani Road, Navarsapur, Bijapur District-586101, Karnataka** run by **Sri Siddalingeshwar Vidyavardhak Sangh, Bijapur District, Karnataka** for conducting **B.Ed.** programme of two year duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
