**ORDER**

**WHEREAS**, the Avinasi Gounder Mariammal College of Education, 12, Gandhiji Street, Karur Bye-Pass Road, Koilampalayam, Erode, Tamilnadu-638002 was granted recognition for conducting (M.Ed.) course of one-year duration with an annual intake of 100 students vide SRC, NCTE vide order no. F.SRO/NCTE/M.Ed./2006-2007/14099 dt. 05.11.2007.

**AND WHEREAS**, the consequent upon the notification of the National Council for Teacher Education (Amendment) Regulation, 2010 on dt. 26.07.2010 the intake of existing 25 students in M.Ed. course was increased from 25 to 35 vide SRC, NCTE order no. F.SRO/NCTE/2010-2011/20883 on dt. 01.09.2010.

**AND WHEREAS**, after the promulgation of NCTE Regulations, 2014 and as per affidavit submitted by the institution on dt. 05.02.2015 and the provisional revised recognition order was issued on dt. 22.05.2015 to the institution for conducting M.Ed. programme of two years duration with an annual intake of 50 students for one basic unit from the academic session 2015-2016.

**AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 381<sup>st</sup> Meeting held on 31<sup>st</sup> October & 01<sup>st</sup> November 2019 considered the matter and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

**AND WHEREAS**, as per the decision a Show Cause Notice was issued to the institution on dt. 28.08.2019 but the institution did not submit Show Cause Notice reply.

**AND WHEREAS**, for non-submission Show Cause Notice reply the matter was placed before the SRC in its 386<sup>th</sup> meeting held on 23<sup>rd</sup> & 24<sup>th</sup> July 2020 wherein the Committee decided to issue Final Show Cause notice was issued to the institute vide letter dt. 30.07.2020.

**AND WHEREAS**, the institution has submitted its reply dt. 14.09.2020 along with all desired documents.

**AND WHEREAS**, the above matter was placed before the SRC in its 390<sup>th</sup> Meeting held on 28<sup>th</sup> & 29<sup>th</sup> October 2020 and the Committee considered the matter and decided to write a letter to the institution to submit the following:-

1. **The institution is required to submit the latest staff list (in prescribed format) duly approved by the concerned affiliating university.**
2. **The institution is required to submit the FDRs of Rs. 7+5 Lakhs maintained under joint operation with RD, SRC and institution /management towards Endowment and Reserve Fund alongwith Form 'A' issued by the concerned Bank.**

**AND WHEREAS**, the institution vide its email dt. 02.11.2020 has submitted the documents.

**AND WHEREAS**, the compliance submitted by the institution on dt. 02.11.2020 and the matter was considered by the SRC in its 391<sup>st</sup> Meeting held on dt. 03<sup>rd</sup> November 2020 as under: -

“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution **Avinasi Gounder Mariammal College of Education, Kollampalayam, Erode-2** for the following courses: -

- (i) **B.Ed. - 2 units (50 students each unit).**
- (ii) **M.Ed.- 1 unit of 50 students.”**

**NOW THEREFORE**, the SRC decided to permit the institution i.e. **Avinasi Gounder Mariammal College of Education, Gandhiji Street, Karur Bye-pass Road, Kollampalayam, R.S. No. 1240/1A1, Kasipalayam, Erode Taluk, Erode District, Tamilnadu-638002** for M.Ed. course run by **Avinasi Gounder Mariammal Trust** for continuation of recognition for M.Ed. course of **two years duration with an annual intake of 50 students (one basic unit)** subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
12. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
13. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
- a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.
  - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

16. The institution shall make available the list of students admitted on its official website.
17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
