WITHDRAWAL ORDER

WHEREAS the recognition was granted to K.G.V.A Sangha's Matoshree Kantamma Sanganagouda Patil College of Education for women, Hirur Taluk, Muddebihal, Bijapur District, Karnataka-586214 for B.Ed. course vide order no. F.SRO/NCTE/B.Ed./2006-2007/5353 dt. 03.12.2007 for conducting Secondary (B.Ed.) course of one-year duration from the academic session 2005-2006 with an annual intake of 100 (Hundred) students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 24.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 28.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the status of issuance of Show Cause Notice/FSCN was considered by the Sub-Committee constituted by the SRC in its Meeting held on 22nd Oct, 2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. As per the decision of SRC a First Show Cause Notice was issued to the institution on dt. 24.01.2019. The institution vide letter dt. 16.11.2019 submitted its reply to the First Show Cause Notice along with the documents.

AND WHEREAS, the SRC in its 387th Meeting of the SRC held on 24th & 25th August 2020 the matter was placed before the meeting and the Committee was considered the matter and decided as under: -

1. The area of multipurpose hall and site area is not mentioned in the building plan. Built up area mentioned in the building plan is not

AND WHEREAS, as per directed a Final Show Cause Notice was issued to the institution on dt. 01.09.2020.

AND WHEREAS, the SRC in its 393rd Meeting held on 05th & 06th January 2021 and considered the matter as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1. The institution has not responded to the Final Show Cause Notice issued on 01.09.2020."

NOW THEREFORE, the Committee decided to withdraw the recognition granted to K.G.V.A Sangha's Matoshree Kantamma Sanganagouda Patil College of Education for women, Hirur Taluk, Muddebihal, Bijapur District-586214 for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
