#### WITHDRAWAL ORDER

WHEREAS, the institution Blessy College of Education, Navalingam Nagar, Chidambaram Taluk, Cuddalore District-608001, Tamilnadu SRC (NCTE) vide granted recognition F.SRO/NCTE/B.Ed./2006-2007/18830 dated 17.03.2006 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2006-2007.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 22.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the matter was placed before in 314th meeting of SRC held on 27th 28th May 2016 wherein a general decision was taken to cause inspection of such cases.

AND WHEREAS, as per the decision of SRC, inspection of the institution was conducted on 23.10.2016 to 12.11.2016.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

**AND WHEREAS**, the institution has not submitted any documents as a result a Final Show Cause Notice was sent to the institution on 24.10.2019 as decided in  $380^{th}$  meeting held on  $18^{th}$  –  $19^{th}$  September, 2019 by Sub-Committee.

**AND WHEREAS**, the institution submitted its reply along with documents dt. 28.10.2019.

**AND WHEREAS**, SRC in its 384<sup>th</sup> Meeting of SRC held on 12<sup>th</sup> & 13<sup>th</sup> February 2020 the matter was placed, and the Committee decided to issue a Final Show Cause Notice to the institution.

**AND WHEREAS**, the institution submitted its reply along with the documents on dt. 11.03.2020.

**AND WHEREAS**, SRC in its 386<sup>th</sup> Meeting of SRC held on 23<sup>rd</sup> & 24<sup>th</sup> July, 2020 and the matter was placed and the Committee decided to issue a letter to the institution to submit the written representation to the conditions mentioned therein.

**AND WHEREAS**, as per the decision a Communication letter was issued to the institution on dt. 17.08.2020.

AND WHEREAS, the institution has submitted its reply on dt. 14.09.2020.

**AND WHEREAS**, the SRC in its 393<sup>rd</sup> Meeting held on 05<sup>th</sup> & 06<sup>th</sup> January 2021 and considered the matter as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the reply submitted by the institution on 14.09.2020 in respect to the Final Show Cause Notice and found the following deficiencies: -

- 1. The institute failed in submission of certified copies of land documents with notarized English translation in favour of society/institute/trust as required under NCTE Regulations, 2014.
- 2. The institute had not submitted satisfactory reply of the deficiency related to the variation of survey nos. and dates of issuance of LUCs.
- 3. The institute submitted the approval of faculty vide dt. 29.12.2015 and failed to submit latest approval of faculty issued by the affiliating university.
- 4. The faculty was approved in 2015 and it is not established that the same faculty is working as on date or not in the institute.
- 5. The institute failed in submission of English translation of NEC notarized.
- 6. As per the building plan submitted by the institute the multipurpose Hall is not available in the institute."

NOW THEREFORE, the Committee decided to withdraw the recognition granted to Blessy College of Education, Navalingam Nagar, Chidambaram Taluk, Cuddalore District-608001, Tamilnadu for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a>, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
