AND WHEREAS, the SRC in 381st meeting held on 31st Oct & 1st Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, First Show Cause was issued on 06.11.2019.

AND WHEREAS, the institution vide letter dated 25.11.2019 submitted its reply to the First Show Cause Notice.

AND WHEREAS, the matter was placed before the SRC in its 392nd meeting held on 15th - 16th December, 2020 considered and decided as the following grounds:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution NDRK College of Education, B.M. Road, Hassan-573201, Karnataka for B.Ed programme for 2 basic units of 50 students each unit."

NOW THEREFORE, this order is issued permitting the institution i.e. NDRK College of Education, 147/2, B.M. Road, Hassan-573201, Karnataka for continuation of recognition for B.Ed programme for 2 basic units of 50 students each unit subject to fulfilment of the following conditions:

- The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint I. account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- The institution shall comply with the various other norms and standards prescribed in 11. the NCTE Regulations, 2014 as amended from time to time.
- The institution shall make admissions only after it obtains affiliation from the III. examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- The institution shall ensure that the required number of academic staff duly approved IV. by affiliating body for conducting the course should always remain in position.
- Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as
- 2. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered
- The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter - alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall
