ORDER

WHEREAS, the Crescent College of Education, Karimnagar Revenue Division, #2-8-237, Mukarrampura, Karimnagar District-505001, Telangana had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Crescent College of Education, Karimnagar Revenue Division, #2-8-237, Mukarrampura, Karimnagar District-505001, Telangana for B.Ed course one year from the academic session 2002-2003.

2. AND WHEREAS, the recognition was granted to the institution on 27.05.2003 with an annual intake 100 students from the academic session 2002-2003 with a condition that the institution shall shift to its own premises within three years from the date of recognition (in case the course is started in rented premises).

3. AND WHEREAS, the SRC in its 178th meeting held on 13th-14th July, 2009 considered the list of institutions were accorded recognition in the rented premises and they had not yet shifted to the permanent building and it has decided to issue show cause notice under section 17 of NCTE Act and obtain shifting fees and other documents for causing inspection for shifting.

4. AND WHEREAS, a letter was issued to the institution on 01.09.2009. The institution has submitted its written representation along with DD of Rs.40.000/- bearing no.318575 dated 17.09.2009 on 01.10.2009.

5. AND WHEREAS, inspection intimation was sent to institution on 25.01.2011. Accordingly, shifting inspection of the institution was carried out on 12.02.2011. As per VT

6. AND WHEREAS, after long deliberation in SRC meetings held from time to time and also deliberation held by the SRC in its 350th meeting held on 21st & 22nd December, 2017 considered the matter and decided as under:

- 1.1 Their reply is satisfactory,
- 1.2 The faculty list for D.El.Ed is in order.
2. Issue Shifting -permission w.e.f. 2017-18 for both B.Ed (2 units) & D.El.Ed (1 units).
3. Issue new FR under the 2014 Regulations at the new address for B.Ed (2 units).

7. NOW THEREFORE, this order is issued permitting the institution i.e. Crescent College of Education, Sy. No. 3/2, No. 2-8-44-4, Qudratnagar, Faran Street, Peddapalli, Karimnagar District, Telangana run by Crescent Educational And Welfare Society, 2-8-44/4, Qudratnagar, Faran Street, Peddapalli, Karimnagar District, Telangana for

continuation of recognition for B.Ed course of two years duration with an intake of 100 students (two units of 50 each subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

12. The institution shall make available the list of students admitted on its official website.
13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
