AND WHEREAS, the recognition was granted to the institutionkl namely, Mannam Foundation for Teacher Education Technology, Chathakulam, Poruvazhy P.O. Kollam-690520, Kerala run by Mannam Foundation for Teacher Education Technology, Chathakulam, Poruvazhy P.O. Kollam-690520, Kerala vide SRC (NCTE) order No.F.KL/SEC/N/240/SRO/NCTE/2004-2005/902 dated 25.02.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 24.01.2015 for its willingness for adherence of provisions of new Regulations.
- AND WHEREAS, a Revised Provisional Recognition Order was issued to the 3. institution on 29.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016.
- AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC, a show cause notice was issued to the institution on 17.07.2019. The institution did not reply to Show Cause Notice till date.
- AND WHEREAS, the matter was further considered by the SRC in its 380<sup>th</sup> Meeting held on 18th -19th September 2019 and the Committee decided as follows:-
  - 1. The institution has not submitted a certified copy of land documents. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
  - 2. The institution has not submitted a copy of Land Use Certificate. institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority.
  - 3. The institution has not submitted a copy of Non Encumbrance Certificate issued by the Competent Authority. The institution is required to submit an copy of Non - Encumbrance Certificate issued by the attested/notarised Competent Authority.
  - 4. The institution has not submitted a copy of approved building plan. The institution is required to submit an attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)

5. An attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.

6. The institution has not submitted a copy of Building Completion Certificate. The Institution is required to submit an attested/notarised copy of Building

Completion Certificate issued by the competent authority.

7. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)

8. The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alongwith a copy of the FDRs

13. The institution shall be required to submit an Affidavit clearly stating status about land & building and Management (Society/Trust) at the time of recognition and its present status giving following details

(i) Details of land & building available at the time of recognition with the

Institution

(ii) Details of land & building now available with the Institution

(iii) Status of Management at the time of recognition and its present status

In case of change of land & building or the Management at the time of recognition and thereafter the institution is required to specify the reason thereof with approval of the SRC, NCTE.

Therefore, the Committee decided to issue **Final Show Cause Notice u/s 17 of NCTE Act**, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of **Final Show Cause Notice**.

- 6. **AND WHEREAS,** as per decision taken in the meeting 380<sup>th</sup>, a Final Show Cause was issued to the institution on **31.10.2019**. In response, the institution submitted its reply on **15.11.2019**.
- 7. **AND WHEREAS**, the matter was further considered by the SRC in its 389<sup>th</sup> meeting held on October 12<sup>th</sup> & 14<sup>th</sup>, 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) dated 31.10.2019. The institution has submitted its reply on 15.11.2019. The Committee considered the reply and found the following deficiencies: -

- 1. The institution has not submitted land use certificate duly approved by the competent authority.
- 2. The Latest Encumbrance Certificate submitted by the institution is not approved by the competent authority. The institution has not submitted notarized English version of NEC.
- The institution has submitted building plan which is not approved by the competent authority. The Survey No. & size of the multipurpose hall is not mentioned in the Building Plan. The Class Rooms size is not as per NCTE Regulations.
- 4. The Site Plan submitted by the institution is not approved by the competent authority.
- 5. The BCC submitted by the institution is not in format and not approved by the competent authority.
- 6. The Staff list submitted by the institution was not approved by the Registrar, of Concerned Affiliating University / Body. The following lecturers are not qualified as per NCTE (Recognition Norms & Procedure) (Amendment) Regulation, 2017 dated 29.05.2017 notified on 09.06.2017.
  - a. Smt. Gourikrishna. G works as an Assistant Professor in English appointed on 01.07.2017.
  - b. Smt. Seethalekshmi.B works as an Assistant Professor in Natural Science appointed on 16.09.2019.

- c. Smt. Keerthy.G. Krishnan Works as an Assistant Professor in General Education appointed on 16.09.2019.
- d. The institution has not appointed Physical education, Fine Arts and Performing Arts.

Hence, the Committee decided to withdraw the recognition granted to Mannam Foundation for Teacher Education Technology, Chattakulam, Poruvazhy P.O. Kallam-690520, Kerala for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Mannam Foundation for Teacher Education Technology, Chattakulam, Poruvazhy P.O. Kallam-690520, Kerala for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.
- **9.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

**10.** Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
