CONTINUATION ORDER**

WHEREAS, the recognition was granted to the institution namely, **H. H. Marthoma Mathew II Training College, Adoor, Pathanamthitta District, Kerala-691529** vide SRC order No. F.KL/SEC/N/179/SRO/NCTE/2004-2005/903 on 25.02.2005 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

2. **AND WHEREAS**, in exercise of the powers conferred by sub-section (2) of Section 32 of the NCTE Act, 1993 (73 of 1993) the NCTE (Recognition Norms and Procedure), Regulations, 2014 were notified on 01.12.2014 in supersession of the NCTE (Recognition Norms and Procedure), Regulations, 2009.

3. **AND WHEREAS**, the institution had **not submitted an affidavit** as its acceptance for adherence to the provisions of the NCTE Regulations, 2014 and therefore, a revised provisional recognition order (RPRO), as per NCTE Regulations, 2014, was not issued to the institution.

4. **AND WHEREAS**, the SRC in its 294th meeting held on 14th – 16th November 2015 considered the matter and decided to issue show cause notice. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 20.05.2016. The institution did not submitted reply to the Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 386th meeting held on 23rd & 24th July 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 05.08.2020. The institution has submitted reply on 09.11.2020 & 18.11.2020.

6. **AND WHEREAS**, the SRC in its 392nd meeting held on 15th -16th December 2020 considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a withdrawal order no. F.SRO/NCTE/APS00704/B.Ed./KL/2020/121617-1623 dt. 22.12.2020 was issued to the institution.

7. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-129/E-182725/2021 Appeal/16th Mtg.-2021/ dt. 07.07.2021 appeal remand back the Order appealed against. The institution has submitted reply on 05.08.2021.



8. **AND WHEREAS**, the SRC in its 401st Meeting held on 11th & 12th August 2021 considered the matter and decided to issue Final Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued on 28.08.2021. The institution has submitted reply on 08.9.2021.

9. **AND WHEREAS**, the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the matter and decided as follows: -

“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

*The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **H.H. Marthoma Mathew II Training College, Survey No. 381/2, Ward No. 24, Adoor Municipality, Pathanamthitta District-691529, Kerala for B.Ed. programme for 1 basic unit of 50 students.**”*

10. **NOW THEREFORE**, this order is issued permitting the institution i.e., **H.H. Marthoma Mathew II Training College, Survey No. 381/2, Ward No. 24, Adoor Municipality, Pathanamthitta District-691529, Kerala** run by **Socio Economic Education Christian Development Society, Avantapur District, Andhra Pradesh** for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **1 basic unit of 50 students** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

12. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.

16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the

Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
