WHEREAS, the institution Star College of Education, Sy.No.343/5B, Periyamanali Village, Tiruchengode (Taluk), Namakkal District - 637410, Tamilnadu was granted recognition for conducting (B.Ed.) course of one-year duration with an annual intake of 100 students vide SRC, NCTE's vide order no. F.SRO/NCTE/B.Ed./2006-2007/8677 dated 24.10.2006 from the academic session 2006-2007.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 20.01.2015, the provisional revised recognition order was issued to the institution on 05.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16. The institution submitted a letter dated 27.09.2016 requesting for reduction of intake from 2 units to 1 unit was permitted. Accordingly, an order for reduction of intake from 2 units to 1 unit was issued on 04.10.2017.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and committee decided that Show Cause Notice was issued to all such institution which have not submitted compliance. As per the decision, a Show Cause Notice was issued to the institution vide dated 03.05.2019. The institution had submitted its reply vide letter dated 01.08.2019.

AND WHEREAS, the matter was placed before the SRC in its 380th meeting held on 18th -19th September 2019, the Committee considered and decided to issue Final Show Cause Notice. As per the decision, a Final Show Cause Notice was issued to the institution vide dated 25.09.2019. The institution has submitted its reply along with documents vide dated 13.12.2019.

AND WHEREAS, the matter was placed before the SRC in its 384th meeting held on 12th -13th February, 2020, the Committee considered the matter and decided to withdraw the recognition granted to Star College of Education, Periyamanali, Tiruchengode, Namakkal, Tamilnadu - 637410 for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993. Accordingly, a withdrawal order was issued to the institution vide dt.21.02.2020. Thereafter, the institution preferred an appeal u/s 17 of NCTE Act, 1993 and the Appellate Authority vide order No. F.No.89-186/E-164924/2020 Appeal/26th Mtg.-2020/27th October, 2020/95242 dt.02.12.2020 remanded back the matter to SRC. The institution has submitted its reply dt. 03.12.2020.

AND WHEREAS, the matter was considered by the SRC in its 392nd meeting held on 15th-16th December 2020 as under: -

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Star College of Education, S. No. 343/5B, Periyamanali Village, Tiruchengode (Taluk) Namakkal District — 637410, Tamil Nadu for B.Ed programme for 1 basic unit of 50 students."

NOW THEREFORE, the SRC decided to permit the institution i.e., Star College of Education, Sy.No.343/5B, Periyamanali Village, Tiruchengode (Taluk), Namakkal District – 637410, Tamilnadu for B.Ed. course run by Star Educational and Charitable Trust, 1-84-C, Elur Road, Periamanali, Trichengode, Namakkal – 637410, Tamilnadu for continuation of recognition for B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 9. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:

- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 12. The institution shall make available the list of students admitted on its official website.
- 13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
