WHEREAS, the recognition was granted to the institution namely Sagar Gangotri Education Institution, J.C. Road, Sagar, Shimoga District- 577401, Karnataka. run by Sri Sigandoorshwari Education Trust, Ullur, "Jnana Grama" No.22'23, N.H. 206, Ullur-577412, Sagar Taluk, Shimoga District, Karnataka vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/2470 dt 11.05.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 03.02.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 18.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the matter was placed before in 314th meeting of SRC held on 27th & 28th May 2016 wherein a general decision was taken to cause inspection of such cases. Accordingly, as per the Decision of SRC, a latter for inspection was sent on dt. 13.06.2016 but Inspection was not conducting.

AND WHEREAS, the matter regarding compliance by the institution of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that First Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision a First Show Cause Notice was issued to the institution on 24.10.2019. The institute submitted its reply along with documents dt.20.11.2019.

AND WHEREAS, the matter was placed before the SRC in its 388th meeting held on 14th – 15th September, 2020 the Committee considered and decided to issue Final show Cause Notice to the institution. In view of the above, a Final Show Cause Notice was issued on 2109.2020. The institution submitted its reply along with documents vide latter dated 24.11.2020.

AND WHEREAS, the SRC in its 392th meeting held on 15th – 16th December 2020 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution on 24.11.2020. The Committee observed the following deficiencies: -

- 1. The institute submitted a copy of Building Plan but it is neither approved nor legible.
- 2. The institute submitted only 11 faculty against the requirement of 16 under NCTE Regulation. The institution has also not appointed faculty for Fine Arts.
- 3. The institution did not submitted copy of FDRs along with 'Form A'.
- 4. The institute submitted a copy of home page of website. Other details of uploading the requisite information on website have not been submitted as required under NCTE Regulations.

Hence, the Committee decided to withdraw the recognition granted to Sagar Gangotri Education Institution, J.C. Road, Sagar, Shimoga District-577401, Karnataka for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Sagar Gangotri Education Institution, Sy No. 23/1 J.C. Road, Sagar, Shimoga District- 577401, Karnataka run by Sri Sigandoorshwari Education Trust, Ullur, "Jnana Grama" No.22'23, N.H. 206, Ullur-577412, Sagar Taluk, Shimoga District, Karnataka for conducting B.Ed. programme of two year duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.nctc-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
