WHEREAS, the institution Dr. S.R.J. College of Education, No. 15, VOC Nagar, Thanjavur District - 613007, Tamil Nadu was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/9178 dated 13.11.2006 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2006-2007. The recognition was granted with a condition that the institution would shift to its own premises/building within 3 years from the date of recognition.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 22.01.2015, the provisional revised recognition order was issued to the institution on 13.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16.

AND WHEREAS, the institution vide letter dated 27.07.2015 has shifted to its new building / premises at "Dr. S.R.J. College of Education, 116/6, Palliyagraharam, Thanjavur -Kumbakonam National Highways, Thanjavur - 613003, Tamil Nadu" without NCTE permission. The matter was placed before the SRC in its 324th meeting held on 07th - 08th December 2016. The Committee considered the matter and decided that no inspection is required in this case, ask institution to submit the documents. The institution has not submitted any reply till date.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued on 07.05.2019.

AND WHEREAS, The SRC constituted a Sub-Committee in 380th meeting decided to issue Final Show Cause Notice to all such institution which have not submitted SCN Reply / or submitted partial reply of SCN. Accordingly, a Final Show Cause Notice was issued on 15.11.2019. The institution has submitted its reply in respect of Final Show Cause Notice on 09.12.2019.

AND WHEREAS, the matter was placed before the SRC in its 386th meeting. The Committee considered the matter and decided to withdraw the recognition granted to the institution for B.Ed course on the basis of deficiencies mentioned therein. Accordingly, a Withdrawal order was issued on 04.08.2020.

AND WHEREAS, the institution preferred an Appeal and the Appellate Authority vide its letter dt 27.11.2020 considered the appeal and decided to Remand back the case of the institution. The institution has submitted its reply 01.12.2020 as directed by Appellate Authority.

AND WHEREAS, the matter was considered by the SRC in its 392nd meeting held on 15th-16th December 2020 as under: -

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Dr. S.R.J. College of Education, No. 15, VOC Nagar, Thanjavur District – 613007, Tamil Nadu for B.Ed programme for 2 basic units of 50 students each unit."

NOW THEREFORE, the SRC decided to permit the institution i.e., Dr. S.R.J. College of Education, Survey No.-116/6A, No. 15, VOC Nagar, Thanjavur District - 613007, Tamil Nadu for B.Ed. course run by Dr. S.R.J. Educational & Charitable Trust, 9, Jayram Nagar, Medical College Road, Thanjavur - 613007, Tamil Nadu for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic unit) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 10. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 11. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter—alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such

as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 14. The institution shall make available the list of students admitted on its official website.
- 15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
