**ORDER**

**WHEREAS**, the institution **Gananamani College of Education, No. 9, Pudupalayam Road, Rasipuram, Namakkal District, Tamilnadu-637408** was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/M.Ed./2006-2007/15782 dated 07.12.2007, for conducting M.Ed. course of one year duration with an annual intake of 25 students from the academic session 2006-2007.

**AND WHEREAS**, enhancement of intake of 10 seats from existing 25 to 35 permitted namely Gananamani College of Education, Pachal Post, N.H-7, Near RTO office, A.K. Samuthiram, Namakkal District, Tamilnadu-637018 for M.Ed. course dt. 20.08.2010 for session 2010-2011.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 13.01.2015 for its willingness of two units in M.Ed. course and adherence of provisions of new Regulations.

**AND WHEREAS**, the provisional revised recognition order was issued to the institution on 25.05.2015 for conducting **M.Ed. course of two years duration with an annual intake of 50 (one basic units) from the academic session 2015-16.**

**AND WHEREAS**, the matter was placed before 317<sup>th</sup> meeting held on 28<sup>th</sup> to 30<sup>th</sup> June 2016 and committee was considered the matter and the Committee was decided to issue **First Show Cause Notice** to the institution.

**AND WHEREAS**, a First Show Cause Notice was issued to the institution vide dated 10.08.2016. The institution was submitted compliance on dt. 16.01.2017 for course M.Ed. against Show Cause Notice dt. 10.08.2016. The institution was not submitted any compliance against RPRO for M.Ed. course.

**AND WHEREAS**, the matter was considered by the SRC in its 369<sup>th</sup> meeting held on 28<sup>th</sup> January 2019 wherein the Committee decided to issue Show Cause Notice u/s of the NCTE, 1993 before withdrawal of recognition.

**AND WHEREAS**, the institution has submitted a reply dt. 06.06.2019 for SCN for M.Ed. along with the documents. The above representation was placing the SRC in its 381<sup>st</sup> meeting held on 31<sup>st</sup> October -1<sup>st</sup> November 2019. The Committee considered the matter and decided to issue Final Show Cause Notice.

AND WHEREAS, a Final Show Cause Notice was issued on 18.11.2019. The institution has submitted its reply in response to Final Show Cause Notice on 12.12.2019.

AND WHEREAS, the compliance submitted by the institution on dt. 12.12.2019 and the matter was considered by the SRC in its 392<sup>nd</sup> meeting held on 15<sup>th</sup>-16 December 2020 as under: -

“The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution the Committee decided that the **continuation order** be issued to the Institution **Gananamani College of Education, No. 9, Pudupalayam Road, Rasipuram, Namakkal District, Tamilnadu-637408** for the following courses: -

**M.Ed – 1 unit of 50 students.**

Now therefore, the SRC decided to permit the institution i.e. **Gananamani College of Education, No. 9, Pudupalayam Road, Rasipuram, Namakkal District, Tamilnadu-637408** for **M.Ed. course** run by **Christian Educational Development Trust, Namakkal District, Tamilnadu** for continuation of recognition for **M.Ed. course of two years duration with an annual intake of 50 students (one basic units)** subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
  - V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
12. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

13. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
  - a. Sanctioned programme(s) along with annual intake in the institution;
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last quarter;
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.
  - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
  - l.
15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
16. The institution shall make available the list of students admitted on its official website.
17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the

Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
