WHEREAS, the institution Bharat College of Education, No.8, Karar Krishnaswami Street, Kosapet, Vellore District-632001, TamilNadu was granted recognition vide SRC order no. F.TN/SEC/SRO/NCTE/B.Ed./2006-2007/5047 dt.20.06.2007 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2006.2007

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 27.01.2015, the provisional revised recognition order was issued to the institution on 01.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16.

AND WHEREAS, the institution has not submitted any documents as a result a SCN was issued on 03.10.2019. Further, as the institution did not submit any reply a Final Show Cause Notice as decided by the SRC in its 380th meeting held on 18th - 19th September 2019 was issued on 04.12.2019. The institution has not submitted any reply till date.

AND WHEREAS, the above matter was placed before the SRC in its 383rd meeting. The committee considered the matter and decided to withdrawal order was issued to the institution on 21.01.2020. The institution preferred an appeal and the Council vide its order dt.27.11.2020 considered the matter and decided to remand back the case with the direction to submit the documents within 15 days as mentioned therein. The institution has submitted its reply on 01.12.2020.

AND WHEREAS, the matter was considered by the SRC in its 392nd meeting held on 15th-16th December 2020 as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Bharat College of Education, no.8, Karar Krishnaswami Street, Kosapet, Vellore District-632001, Tamilnadu for B.Ed programme for 2 basic units of 50 students each unit."

NOW THEREFORE, the SRC decided to permit the institution i.e., Bharat College of Education, Survey No: T S. No. 1099, No.8, Karar Krishnaswani Shreet, Kosapet, Vellore District-632001, TamilNadu. for B.Ed. course run by Bharat Education Trust, Vellore District, TamilNadu for continuation of recognition for B.Ed. course of two years duration
