WHEREAS, the institution Concord College of Education, Salem Main Road, Avathanapatty, Krishnagiri-635001, Tamilnadu was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/19178 dated 31.03.2008 for conducting B.Ed. course of one year' duration with an annual intake of 100 students.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 16.02.2015, the provisional revised recognition order was issued to the institution on 01.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16. The institution has submitted its online application for shifting of premises, DD of Rs. 1,50,000/- bearing no. 142824 dated 19.10.2015 along with relevant documents on 28.10.2015.

AND WHEREAS, the matter was considered by the SRC in its 298th meeting held on 08th - 10th January 2015 wherein the Committee decided to issue a letter to the institution. Accordingly, a letter dt.28.07.2016 was issued to the institution.

AND WHEREAS, the matter was considered by the SRC in its 343th meeting held on 1-2 August, 2017 wherein the Committee decided to conduct VT. The VT was conducted on 02nd – 03rd November, 2017. The matter was placed before the Committee in its 386th meeting held on 23rd – 24th July 2020. The Committee considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 30.07.2020. The institution has submitted its reply on 26.08.2020.

AND WHEREAS, the matter was placed before the SRC in its 388th meeting. The Committee considered the matter and decided to issue Final Show Cause Notice to submit the compliance in respect to the conditions mentioned therein. As per the decision uploaded on the website. The institution vide its email dt. 27.10.2020 has submitted the documents.

AND WHEREAS, the matter was considered by the SRC in its 392nd meeting held on 15th-16th December 2020 as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

NOW THEREFORE, the SRC decided to permit the institution i.e., Concord College of Education, Survey No.- 181/3A1C, 181/3A1D, 181/3AE, Salem Main Road, Avathanapatty, Krishnagiri-635001, Tamilnadu for B.Ed. course run by Concord Educational Trust, Krishnagiri District, Tamilnadu for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

 V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 8. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. - j. The institution shall be free to post additional relevant information, if it so desires.
