WHEREAS the institution Dr. S.N.S College of Education, No. 487, Thudiyalur - Sarvanampatti Road, Coimbatore, Tamilnadu-641006 was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/15317 dt. 28.11.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 14.01.2015, the provisional revised recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16. Thereafter, the institution submitted compliance against RPRO issued in respect of B.Ed. course vide letter dt. 30.10.2015.

AND WHEREAS, the matter was placed before in 314th meeting of SRC held on 27th & 28th May 2016 wherein a general decision was taken to cause inspection of such cases. Accordingly, as per the decision of SRC, a letter for inspection was sent on 13.06.2016. Thereafter, inspection intimation letter was issued to the institution on 13.06.2016, VT members names were generated through online VT module for inspection during the period 23.10.2016 to 12.11.2016. Inspection of the institution was done on 24.10.2016 and VT was received on 04.11.2016.

AND WHEREAS, the SRC in its 329th Meeting held on 06th & 07th February 2017, the Committee considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 09.02.2017. Thereafter, the institution vide letter dt. 28.02.2017 also submitted documents regarding compliance of RPRO.

AND WHEREAS, the matter was placed before the SRC in its 375th meeting held on 13th & 14th May 2019 and the Committee considered the matter and decided to present personally before the Committee with all the above documents by next meeting. Thereafter, SRC in its 377th meeting of SRC held on 03rd & 04th July, 2019, the matter was placed and decided to issue Final Show Cause Notice and Final Show Cause Notice was issued to the institution on dt. 12.07.2019. Thereafter, the institution submitted reply of Final Show Cause Notice vide letter dt. 13.07.2019.

AND WHEREAS, the above matter was placed before the SRC in its 384th meeting. The Committee considered the matter and decided to withdraw the recognition granted for B.Ed course of the institution. Accordingly, a withdrawal order was issued to the institution on 23.02.2020. The institution preferred an appeal and the appellate authority considered the matter and decided to Remand back the case of the institution with the direction to submit the reply to the conditions mentioned in the council's order dt. 19.11.2020. Now, the institution has submitted its reply on 03.12.2020.

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Dr. S.N.S College of Education, No. 487, Thudiyalur - Sarvanampatti Road, Coimbatore, Tamilnadu-641006 for B.Ed programme for 2 basic units of 50 students each unit."

NOW THEREFORE, the SRC decided to permit the institution i.e., Dr. S.N.S College of Education, Survey No.- 486/1, 486/2, 487/1, Thudiyalur - Sarvanampatti Road, Coimbatore, Tamilnadu-641006 for B.Ed. course run by Sri SNS Charitable Trust, Coimbatore, Tamil Nadu for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

- The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually.

 Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
