AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 07.07.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 09.07.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-2016

AND WHEREAS, reduction from two basic units (100 students) to one basic unit (50 students). Accordingly, a vide corrigendum order no. F.No.SRO/NCTE/APSO3302/B.Ed/TN/2017-18/95004 dated 19.09.2017 was issued on 19.09.2017 to the institution.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND WHEREAS, as per the decision of SRC a show cause notice was issued to the institution on 03.05.2019.

AND WHEREAS, the institute had submitted its reply on 13.08.2019 along with the documents The SRC in its 379th meeting held on 21st - 22nd August 2019 considered the reply submitted by the institution and decided as under: -

"On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to Dr. G.R. Damodaran College of Education, Sengodagoundenpudur, Muthagoundenpudur Post, Sulur Via, Coimbatore-641406, Tamilnada for B.Ed programme for 1 unit of 50 students".

NOW THEREFORE, this order is issued permitting the institution Dr. G.R. Damodaran College of Education, Sengodagoundenpudur, Muthugoundenpudur Post, Sulur Via, Coimbatore-641406, Tamilnada run by The GRD Trust for continuation of conducting B.Ed course of two years duration with an intake of 50 students (one basic unit of 50 students) subject to fulfilment of the following conditions:
