WHEREAS, the recognition was granted to the institution, namely Jamal Mohamed College of Teacher Education, No.7, Race Course Road, Thiruchira palli-620020, Tamilnadu run by Society of Jamal Mahamed College for conducting Secondary (B.Ed.) course of one-year duration with an intake of 100 students on 02.11.2007.

AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by a notarized affidavit dated 27.01.2015 consented to come under new Regulations.

AND WHEREAS, the Southern Regional Committee (NCTE) issued the revised provisional recognition order dt. 05.05.2015 to Jamal Mohamed College of Teacher Education, No.7, Race Course Road, Thiruchirapalli-620020, Tamilnadu for conducting B.Ed. course of two years duration with an annual intake of 100 students [Two basic units of 50 students each] from the academic session 2015-2016 subject to fulfilment of conditions mentioned therein.

AND WHEREAS, the matter was placed before in SRC 314th meeting held on 27th & 28th May, 2016 wherein a general decision was taken to cause inspection of such

AND WHEREAS, the institution has submitted a letter on 14.07.2016 along with the inspection fee. However, no inspection was conducted.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND WHEREAS, a Show Cause Notice was issued to the institution on 31.01.2019.

AND WHEREAS, the institution has submitted its reply on 18.02.2019 in respect of SCN issued above.

AND WHEREAS, the above matter was placed before the SRC in its 374th meeting held on 09th -10th April 2019 considered the SCN reply and decided as under: -

"The Committee decided that the institution may be permitted for continuation of B.Ed course of two years duration for an annual intake of 100 (2 basic units). Necessary orders may be issued."

AND WHEREAS, the same case was placed before the Committee in its 375th meeting held on 13th – 14th May 2019 for reconsideration of the decision taken by the SRC in its 374th meeting. The Committee considered the matter and decided to issue Show Cause Notice on the grounds mentioned therein.

AND WHEREAS, a show cause notice was issued on 28.05.2019.

AND WHEREAS, the institute had submitted its reply on 14.08.2019 along with the documents The SRC in its  $379^{\text{th}}$  meeting held on  $21^{\text{st}}-22^{\text{nd}}$  August 2019 considered the reply submitted by the institution and decided as under: -

"On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to Jamal Mohamed College of Teacher Education, No.7, Race Course Road, Thiruchirapalli-620020, Tamilnadu for B.Ed programme for 2 units (50 students each unit)."

NOW THEREFORE, this order is issued permitting the institution Jamal Mohamed College of Teacher Education, No.7, Race Course Road, Thiruchirapalli-620020, Tamilnadu run by Society of Jamal Mahamed College for continuation of conducting B.Ed course of two years duration with an intake of 100 students (two basic units of 50 students each) subject to fulfilment of the following conditions:

The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually.
 The institution shall comply with the reserve fund of Rs. 7 lakhs kept in Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

6. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

- 7. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification. Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter:
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 10. The institution shall make available the list of students admitted on its official website.
- 11. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993. Also order that a copy of this Order be published in the official Gazette.
