WHEREAS, the recognition was granted to the institution, namely B.K.R. College of Education, No. 45/22E, Madras Bye Pass Road, Thiruttani – 631209, Tamil Nadu run by Solaraju Dhanushkodi Raja Thai Ammal Memorial Educational Charitable Trust for conducting B.Ed. course of one year duration with an intake of 100 students on 24.11.2005.

AND WHEREAS, SRC in its 181st Meeting held on 20-21 August 2009 decided that the institution which have not shifted to the permanent premises even after the expiry of 3 years' time limit be issued notice under section 17 of NCTE Act, for further action. As per the decision of SRC a notice under Section 17 was issued to the institution on 16.09.2009. The reply from the institution was not received and therefore withdrawal order was issued on 01.07.2010.

AND WHEREAS, the institution preferred an appeal against the withdrawal order issued on 01.07.2010. The Appellate Authority vide order dated 17.09.2010 reversed the SRC's order and directed SRC for causing composite inspection.

AND WHEREAS, the above matter was placed before SRC in its 197<sup>th</sup> Meeting held on 13-14 October 2010 and decided to cause inspection. Accordingly, inspection was conducted, and report received on 10.12.2010.

**AND WHEREAS**, the above inspection report was placed before the Committee in its 199<sup>th</sup> meeting held on 22<sup>nd</sup> – 23<sup>rd</sup> December 2010 and decided to serve show cause notice. Accordingly, show cause notices were issued on 05.05.2011, 15.07.2011, 17.11.2011, 21.05.2012 & 29.10.2012.

AND WHEREAS, the institution submitted its reply on 13.07.2011, 18.07.2011, 09.09.2011, 21.02.2012 & 30.01.2013 and the same were placed before the Committee in its 242<sup>nd</sup> Meeting held on 14<sup>th</sup> – 16<sup>th</sup> April 2013. The Committee considered the reply and decided to withdraw the recognition for B.Ed course. Accordingly, withdrawal order was issued on 11.06.2013.

AND WHEREAS, the institution preferred an appeal against the withdrawal order issued on 11.06.2013. The Appellate Authority vide order dated 13.01.2014 remanded back the case to SRC.

- (ii) The Govt. of Tamil Nadu vide Gazette Notification dated 15th June 2011 also notified the change in the name of the Trust as GRT Mahalakshmi Educational Charitable Trust. The office of the I.T. Department vide letter dated 16.11.2011 also conveyed the approval of the Director of Income Tax (Exemptions), Chennai for the amendment to the trust deed as GRT Mahalakshmi Educational Charitable Trust.
- (iii) Further the institution submitted all the required documents for consideration of the request of the institution for issuance of continuation order for B..Ed programme for 2 units.

In view of the above, the Committee decided that the continuation order be issued to GRT College of Education, No. 45/22E, Madras Bye Pass Road, Thiruttani – 631209, Tamil Nadu for B.Ed programme for 2 units.

NOW THEREFORE, this order is issued permitting the institution GRT College of Education, No. 45/22E, Madras Bye Pass Road, Thiruttani – 631209, Tamil Nadu run by GRT Mahalakshmi Educational Charitable Trust for continuation of conducting B.Ed course of two years duration with an intake of 100 students (two basic units of 50 students each) subject to fulfillment of the following conditions:

- The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 7. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such

as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

a. Sanctioned programme(s) along with annual intake in the institution:

b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

c. Name of faculty members who left of joined during the last, quarter:

d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e. Fee charged from students;

f. Available infrastructural facilities;

g. Facilities added during the last quarter;

h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

i. The affidavit with enclosure submitted along with application.

j. The institution shall be free to post additional relevant information, if it so desires.

- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 10. The institution shall make available the list of students admitted on its official website.
- 11. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993. Also order that a copy of this Order be published in the official Gazette.
