WHEREAS, recognition was granted to the institution namely B.K.R College of Education, No. 45/22E, Chennai Bye Pass road, Tiruttani – 631209, Tamil Nadu run by Solaraju Dhanushkodi Raja Thai Ammal Memorial Educational Charitable Trust on 11.02.2007 for conducting M.Ed course of one year duration with annual intake of 25 students.

AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to B.K.R College of Education, No. 45/22E, Chennai Bye Pass road, Tiruttani – 631209, Tamil Nadu for M.Ed Course on 09.09.2010 with effect from the session 2010-2011.

AND WHEREAS, the withdrawal order was issued to the institution on 10.05.2013 for M.Ed, D.T.Ed and D.T.Ed-Al courses. The Institution preferred an appeal to NCTE, Hqrs and the Appellate Authority vide order no. F.No.59-453/2013 Appeal/18th Meeting 2013 dated 13.01.2014 remanded back the case of B.K.R College of Education to SRC for necessary action as indicated in the order.

AND WHEREAS, the SRC in its 264th meeting held on 1-3 March 2014 considered the Appellate authority order dated 13.01.2014, original approved staff list submitted by the institution vide letter dated 03.07.2013, and other related documents along with the original file of the institution and decided to continue recognition accorded to the institution.

AND WHEREAS, the order for continuance of recognition was issued to the institution on 24.03.2014 for M.Ed course.

AND WHEREAS, on 27.01.2015, the institution submitted an affidavit for offering M.Ed course with an intake of 50 students as per the new Regulations, 2014. Accordingly, a Revised Provisional Recognition Order was issued to the institution for conducting M.Ed programme of two years duration with an annual intake of 50 for one basic unit of 50 students from the academic session 2015-16 on 30.05.2015.

AND WHEREAS, the institution vide letter dated Nil received on 27.07.2015 requested for change of name of college and society from BKR College of Education to GRT College of Education and Sola Raju Dhanuskodi Raja Thai Ammal Memorial Educational Charitable Trust to GRT Mahalakshmi Educational Charitable Trust for both B.Ed. and M.Ed. course.

AND WHEREAS, the request of change in name was placed before the SRC in its 291st meeting held on 20th – 21st August 2015. The Committee considered the matter and decided as under: -

"Change of name and management is permitted"

AND WHEREAS, an order was issued for change in name of institution and management for M.Ed course on 05.11.2015.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND WHEREAS, a Show Cause Notice was issued to the institution on 24.04.2019.

AND WHEREAS, the institution submitted its reply on 08.08.2019 in respect of SCN issued above. The SRC in its 379^{th} meeting held on $21^{st}-22^{nd}$ August 2019 considered the reply submitted by the institution and decided as under: -

(i) "The Committee considered the documents submitted by the institution in response to SCN. The SRC vide order dated 5.11.2015 change of name of the institution and management i.e. Trust

(ii) The Govt. of Tamil Nadu vide Gazette Notification dated 15th June 2011 also notified through Gazette Notification the change in the name of the Trust as GRT Mahalakshmi Educational Charitable Trust. The office of the I.T. Department vide letter dated 16.11.2011 also conveyed the approval of the Director of Income Tax (Exemptions), Chennai for the amendment to the trust deed as GRT Mahalakshmi Educational Charitable Trust.

(iii) Further the institution submitted all the required documents for consideration of the request of the institution for issuance of continuation order for M..Ed. programme for 1 unit.

In view of the above, the Committee decided that continuation order be issued to GRT College of Education, GRT Mahalakshmi Nagar, Chennai-Tirupati Highway, Tiruttani 6312098, Tiruvallur District, Tamilnadu for M.Ed programme for 1 unit"

NOW THEREFORE, this order is issued permitting the institution GRT College of Education, No. 45/22E, Madras Bye Pass Road, Thiruttani – 631209, Tamil Nadu run by GRT Mahalakshmi Educational Charitable Trust for continuation of conducting M.Ed course of two years duration with an intake of 50 students (one basic unit) subject to fulfillment of the following conditions:

 The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

- III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 7. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

- 10. The institution shall make available the list of students admitted on its official website.
- 11. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993. Also order that a copy of this Order be published in the official Gazette.
