WHEREAS, the recognition was granted to the institution Sri Lakshmi Vidyalaya Teacher Training Institute, No. 1974, Vivekananda Nagar, Bangarpet, Kolar District, Karnataka-563114 run by Vijaya Venkateshwara Vidya Samsthe, Bangalore, Karnataka vide SRC vide order no. F.SRO/NCTE/D.Ed.-Al/2004-2005/9141 dt. 03.12.2004 for conducting Elementary (D.Ed.) course of two and half vear's duration with an annual intake of 80 students which includes the existing intake of 60 and an additional intake of 20 students from the academic session 2004-05.

- AND WHEREAS, the institute vide letter dt. 09.06.2021 a requested for closer 2. of the institution.
- AND WHEREAS, the SRC in its 400th Meeting held on 13th & 14th July, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: >

The Committee agreed to close down the institution as requested by the institution vide dated 09.06.2021 by withdrawing the recognition granted to Sri Lakshmi Vidyalaya Teacher Training Institute, No. 1974, Vivekananda Nagar, Bangarpet, Kolar District, Karnataka-563114 for conducting D.Ed. course under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course."
- NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sri Lakshmi Vidyalaya Teacher Training Institute, No. 1974, Vivekananda Nagar, Bangarpet, Kolar District, Karnataka-563114 run by Vijaya Venkateshwara Vidya

Samsthe, Bangalore, Karnataka for conducting **D.Ed. programme** of two years duration with an annual intake 80 students which includes the existing intake of 60 and an additional intake of 20 students w.e.f. the next academic session i.e., 2021-2022 onwards.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
