WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution **Dr. M.R. Reddy College of Education, Dr. M.R. Reddy College Road, Parkal-506164, Warangal, Telangana** vide SRC order No. F. AP/B.Ed/92/SRO/NCTE/2000-2001/83334 dt. 22.10.2001 for conducting **B.Ed** course of one-year duration with an annual intake of 120 students from the academic session 2001-2002.

2. **AND WHEREAS**, the matter of the institution was considered in 66th meeting of SRC and decided to withdraw recognition. Accordingly, a withdrawal order dt. 23.12.2003 issued. The institution further filed the WP 2086/2004 against the withdrawal of recognition and the Hon'ble High Court of Andhra Pradesh at Hyderabad was passed order. The above matter was placed before SRC in its 69th meeting held on 13th February 2004 and decided to accord recognition to Dr. M.R. Reddy College, Parkal from academic 2003-2004 with an intake of 112. Accordingly Recognition Order dt. 18.03.2014 was issued.

3. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution has consented to come under new Regulations and has submitted notarized affidavit dated 19.01.2015. A revised provisional recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students of two basic units from the academic session 2015-16. Further a corrigendum on 01.06.2016 was issued regarding annual intake may be read as "annual intake of 100 for two basic units of 50 students each from the academic session 2015-16".

4. **AND WHEREAS**, a general decision was taken by the SRC in its 314th meeting to cause inspection of such institutions. Accordingly, letter dt.14.06.2016 was issued to the institution for causing inspection but the inspection was not carried out. The institution has submitted an application dated 12.07.2016 requesting therein for reduction of strength from 2 units to 1 unit in its B.Ed course. SRC in its 342nd meeting held on 05th & 06th July 2017 considered the matter and to decided to reduce the intake from 2 units to 1 unit. Accordingly order was issued vide no. F. No. SRO/NCTE/APSO0044/B.Ed./TS/2017-18/94094 dated 21.07.2017.

5. **AND WHEREAS**, The SRC in its 369th meeting held on 28.01.2019 and the Committee Decided that Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, as per the decision of SRC a

show cause notice issued to the institution on 28.02.2019. The institution has submitted dated 23.03.2019 reply to the show cause notice. The SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, Final Show Cause Notice was issued on 14-11-2019. The institution submitted its reply on 05.12.2019.

6. **AND WHEREAS**, the SRC in its 387th meeting held on 24th – 25th August 2020 considered the matter and decided to *withdraw the recognition*. Accordingly, as per the decision of SRC a withdrawal order no. F.SRO/NCTE/APS00044/B.Ed/TS/2020/117879-7885 dated 08.09.2020 was issued to the institution. Aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-211/E-166425/2020 Appeal/2nd Mtg.-2021/19th January 2021 dated 11.02.2021 appeal remand back the Order appealed against. The SRC in its 394th meeting held on 25th – 26th February, 2021 considered the matter and decided issued of Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice issued on 15.03.2021. The institution submitted its reply on 01.03.2021.

7. **AND WHEREAS**, the SRC in its 400th meeting held on July 13th – 14th, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 01.03.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. *At the time of recognition the institution submitted a copy of sale deed dated 27.03.1998. In response to FSCN the institution submitted Deed of Gift settlement deed dated 17.11.2015 Both the land documents are different and the institution failed to submit satisfactory explanation.*
2. *The institution has submitted new CLU at time of submitted of RPRO.*
3. *The institution has submitted photocopy of Building plan but the stamps and signatures of approving authority are not legible. Moreover, the total built up area is not mentioned in Building plan.*
4. *As per the building plan, the size of Multipurpose Hall is shown as 1350 sq.ft. which is less than 2000 Sqft. required under NCTE Regulations, 2014.*
5. *The institution not appointed faculty of Performing Arts, Health and Physical Education and Fine Arts.*

*Hence, the Committee decided to withdraw the recognition granted to **Dr. M.R. Reddy College of Education, Dr. M.R. Reddy College Road, Parkal-506164, Warangal, Telangana** for conducting B.Ed. programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".*


8. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Dr. M.R. Reddy College of Education, Dr. M.R. Reddy College Road, Parkal-506164, Warangal, Telangana** run by **Sadhana Educational Society, Parkal-506164, Warangal District, Telangana** for conducting **B.Ed. course** of two years duration with an annual intake of **50** students (1 basic units) w.e.f. the next academic session i.e., 2021-2022 onwards.

9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
