WHEREAS, the recognition was granted to the institution S.D.M. Trust's B.Ed. College, Terdal-587315, Jamkhandi, Bagalkot District Karnataka run by Sidramappa Danigond Memorial Trust, Jamkhandi, Bagalkot District, Karnataka vide SRC vide order no. F.SRO/NCTE/B.Ed./2004-2005/8979 dt. 01.12.2004 for conducting (B.Ed.) course of oneyear duration with an annual intake of 100 students from the academic session 2004-2005.

- AND WHEREAS, the SRC in its 198th meeting held on 24th-26th November 2010, considered the VT Report and decided to issue Show Cause Notice to the institution. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 11.01.2011. The institution submitted its written representation on 14.02.2011.
- AND WHEREAS, the matter was placed before SRC in its 201st meeting held on 22nd & 23rd February 2011, considered the matter and decided to issue withdraw order. Accordingly, as per decision of SRC vide order no. F.SRO/NCTE/2010-2011/27864 dt. 25.03.2011 withdrawal order was issued to the institution.
- AND WHEREAS, the SRC in its 240th meeting held on 09th-11th March 2013 considered the court order dated 01.02.2013 and noted the matter. Further the committee advised Southern Regional Office to resubmit this case by end of Nov-2013 to check whether the institution has complied with the High Court order that the institution has to submit its reply to the show cause notice already issued, failing which our derecognizing order will have to be reactivated by Feb-2014. Accordingly, as per the decision of SRC, letter was addressed to the institution on 12.04.2013.
- 5. AND WHEREAS, the SRC in its 259th meeting held on 17th-19th January 2014 considered the Hon'ble High Court order dated 03.12.2012 & 28.10.2013 and decided to issue another letter to the institution. Accordingly, as per decision of SRC a letter was issued to the institution on 18.02.2014. Thereafter, the institution has submitted its reply on 25.02.2014.
- AND WHEREAS, the matter was placed before SRC in its 264th meeting held on 1st-3rd March 2014, considered and decided to permit shifting of the institution. Accordingly, as per decision of SRC shifting permission here by accorded to SDM Trust's B.Ed. College, Jamkhandi, Terdal, Karnataka-587315 to shift its premises to the new location/building at S.D.M. Trust B.Ed. College, New Campus, A/p: Terdal, Jamkhandi Taluk, Bagalkot District, Karnataka-587315 order was issued to the institution vide order no. F.No. APSO1894/B.Ed./KA/2013-14/57646 on 24.03.2014.
- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 15.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.

- **8. AND WHEREAS,** the SRC in its 314th meeting held on 27th & 28th May 2016 decided to issue inspection letter to the institution. Accordingly, as per decision of SRC an inspection letter was sent to the institution on 13.06.2016. Thereafter, the inspection of the institution was conducted on 12th & 13th Dec 2016 and VT report received on 15.12.2016.
- 9. AND WHEREAS, the SRC in 381st meeting held on 31st Oct & 1st Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per decision of SRC a First Show Cause Notice was issued to the institution on 08.11.2019. Thereafter, the institution vide letter dated 27.11.2019 submitted reply to the First Show Cause Notice.
- 10. AND WHEREAS, the SRC in its 390th meeting held on 28th-29th October 2020 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 05.11.2020. The institution vide letter dated 18.11.2020 submitted a written representation to Final Show Cause Notice but, the institution did not submit any documents as directed in Final Show Cause Notice dt. 05.11.2020.
- 11. AND WHEREAS, the SRC in its 400th Meeting held on 13th & 14th July 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted a representation dt. 18.11.2020 requesting to submit the documents up to 08.12.2020 but the institution failed in submission of its reply with all relevant documents asked under Final Show Cause Notice dt. 05.11.2020 till date.

Hence, the Committee decided to withdraw the recognition granted to S.D.M. Trust's B.Ed. College, Terdal-587315, Jamkhandi, Bagalkot District Karnataka for conducting B.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 12. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to S.D.M. Trust B.Ed. College, New Campus, A/p: Terdal, Jamkhandi Taluk, Bagalkot District, Karnataka-587315 run by Sidramappa Danigond Memorial Trust, Jamkhandi, Bagalkot District, Karnataka for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) w.e.f. the next academic session i.e., 2021-2022 onwards.
- **13.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

14. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
