WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution **Sri Vijaya Sangama Shikshana Mahavidyalaya, V.V. Mutt, V.V. Mutt Road, Hosadurga Taluk, Chitradurga District, Karnataka-577527** vide order no. F.SRO/NCTE/B.Ed./2005-2006/15626 dt. 15.03.2006 for conducting Secondary (**B.Ed.**) course of one-year duration from the academic session 2005-2006 with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 29.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units of 50 students** each from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its meeting held on 22<sup>nd</sup> Oct 2019 considered the matter and decided to issue SCN u/s 17 of the NCTE act issued to the institution to submit its representation / reply to the observation noted by the Regional Committee. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 23.10.2019. The institution has not submit the reply to the Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> & 15<sup>th</sup> September 2020 has considered the matter and decided to issue SCN in all such matters before withdrawal of recognition of the institution as per provision of the NCTE Act, 1993. The matter was considered before the Committee and decided to issue Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 12.10.2020. The institution has submitted reply on 02.11.2020.

5. **AND WHEREAS**, the SRC in its 400<sup>th</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> July 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 02.11.2020. The Committee observed the reply submitted by the institution and found the following deficiencies: -

1. The institution has submitted notarized copy of Encumbrance Certificate in regional language. The order date is not mentioned, and the name & designation of the issuing authority is not mentioned.
2. The institution has submitted notarized copy of Building Plan in which Built-up area, Multipurpose Hall and Survey No. are not readable.
3. The institution has submitted notarized copy of Site Plan in which Survey no. and total extent area is not mentioned.
4. The institution has submitted notarized copy of Building Completion Certificate but not approved by competent authority.
5. The institution has submitted faculty approval letter dated 31.12.2019 approved from the affiliating body in regional language, total faculty approved: 1+9 Lecturers in place of 1+16 which is insufficient.
  - (i) The institution has not appointed 03 Perspective of Education, 01 Fine Arts, 01 Performing Arts and 01 Health & Physical Education.
  - (ii) The date of joining of all staff is not mentioned in Staff list.
6. The institution has not submitted Form 'A'. The tenure of given FDRs are 2 years instead of 5 years.

Hence, the Committee decided to **withdraw the recognition** granted to **Sri Vijaya Sangama Shikshana Mahavidyalaya, V. V. Mutt Road, Hosadurga Taluk, Chitradurga District, Karnataka** for conducting **B.Ed.** programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Sri Vijaya Sangama Shikshana Mahavidyalaya, V. V. Mutt Road, Hosadurga Taluk, Chitradurga District, Karnataka** run by **Sri Vijaya Sangama Shikshana Mattu Grameena Abhivridhi Samsthe, Hosadurga, Chitradurga District, Karnataka** of two years duration with an annual intake of **100** students (2 basic units) w.e.f. the next academic session i.e., 2021-2022 onwards.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

***"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school,***

**College or other Educational Body aided by the Central Government or any State Government."**

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
