WHEREAS, the recognition was granted to the institution KLE Society's College of Education, 131/A/1, A/2, Old P.B. Road, KG & English Medium School Campus, Nipani Taluk, Nipani, District-Belagavi-591237, Karnataka vide SRC vide order no. F.SRO/NCTE/B.Ed./2004-2005/8909 on dt. 30.11.2004 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 24.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.
- 3. AND WHEREAS, the status of issuance of SCN/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22nd Oct., 2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply been submitted. The Sub-Committee decided to issue SCN. Accordingly, as per decision of SRC. Show Cause Notice was issued to the institution on 23.10.2019. The institution has submitted its reply along with the documents on 04.11.2019.
- 4. AND WHEREAS, the SRC in its 384th meeting held on 12th 13th February 2020 has considered the matter decided to constitute VT. Accordingly, as per the decision of SRC, the inspection was conducted on 14.03.2020 and 15.03.2020 and the VT report was received on 18.03.2020.
- 5. AND WHEREAS, the SRC in its 390th meeting held on 28th & 29th October 2020 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 06.11.2020. Thereafter, the institution has submitted reply on 13.10.2020.
- 6. AND WHEREAS, the SRC in its 400th Meeting held on 13th & 14th July 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 06.11.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institute was informed that the faculty namely Mahantesh Giriraj and Sahadev Namdev are not qualified as not possessing NET qualification. The institute submitted that they have instructed faculty to clear the NET in two years. The deficiency is not rectified.
- The institution has submitted xerox copy of Building plan in which survey no. is not mentioned.
- 3. The Building Plan shows the total build up area as 2492 sq. mt. and a school is also being run in the same premise. The build-up area is not sufficient for the institutions.

Hence, the Committee decided to withdraw the recognition granted to KLE Society's College of Education, 131/A/1, A/2, Old P.B. Road, KG & English Medium School Campus, Nipani Taluk, Nipani, District-Belagavi-591237, Karnataka for conducting B.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to KLE Society's College of Education, 131/A/1, A/2, Old P.B. Road, KG & English Medium School Campus, Nipani Taluk, Nipani, District-Belagavi-591237, Karnataka run by K.L.E. Society, Belgaum, Karnataka for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) w.e.f. the next academic session i.e., 2021-2022 onwards.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
