2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 28.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units of 50 students** each from the academic session 2015-16.

of one-year duration with an annual intake of 100 students from the academic session 2005-

3. AND WHEREAS, a corrigendum was issued to the institution vide order no. F.SRO/NCTE/APS03206/B.Ed./KA/2015/78706 dt. 09.12.2015 for conducting B.Ed. programme of two years duration with an annual intake of 50 students of (one unit) from the academic session 2015-16.

4. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted compliance of the revised recognition order. Accordingly, as per decision of SRC a Show Cause was issued to the institution on 30.01.2019. The institution has not submitted reply to the Show Cause Notice.

5. **AND WHEREAS,** the SRC in its 388th meeting held on 14th-15th September 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 22.02.2021. The institution has submitted reply on 19.04.2021.

6. AND WHEREAS, the SRC in its 400th Meeting held on 13th & 14th July 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 19.04.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institute had submitted a copy of Lease Deed dt. 20.07.1974 executed between City Improvement Trust, Bangalore and the Managing Society. The Lease Deed was for the period of 30 years which is expired.
- 2. The building plan submitted by the institute is neither approved by the competent authority nor legible.

- . 3. Faculty of the institute is not approved by the affiliating body.
 - 4. As per the record issued by the Bruhat Bengaluru Mahanagara Palike a School and pre-University College is also being run in the same premise. The institute did not submit the demarcated building plan for all courses and the build - up area is also not sufficient to run the school, pre-university College and B.Ed. course.
 - The institute did not submit documents related to its managing society/trust. 5.
 - 6. The institute did not submit the NEC.
 - 7. The institution has submitted photocopy of FDRs which are matured. The institution has not submitted Form "A" issued by the bank manager towards creation of FDRs of Rs. 7.00 lakh and Rs. 5.00 lakh towards endowment fund and reserve fund.
 - 8. The details of website of the institute have not been submitted.

Hence, the Committee decided to withdraw the recognition granted to Basaveshwara College of Education, 14th main, Vijayanagar, Bangalore-560040, Karnataka for conducting B.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Basaveshwara College of Education, 14th main, Vijayanagar, Bangalore-560040, Karnataka run by Sri Jagajyothi Basaveshwara Sahakara Sangha, Bangalore, Karnataka for conducting B.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) w.e.f. the next academic session i.e., 2021-2022 onwards.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website 9. www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
