## TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, Koviloor Andavar College of Physical Education and Sports Science, North Car Street, Koviloor - 630307, Near Karaikudi. Sivagangai District, Tamilnadu vide SRC order No.F.SRO/NCTE/B.P.Ed./2006-2007/6215 dated 11.07.2007 for conducting B.P.Ed. course of one-year duration with an annual intake of 50 students.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution has consented to come under new Regulations notarized affidavit dated 29.01.2015. A revised provisional recognition order was issued to the institution on 25.05.2015 for conducting B.P.Ed. programme of two years duration with an annual intake of 100 one basic unit (two section of 50 students each) from the academic session 2015-16.
- 3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the Committee decided to issue a Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 19.07.2019. The institution has submitted reply received on 20.09.2019.
- 4. AND WHEREAS, the SRC in its 382nd meeting held on 26th - 27th November, 2019 has considered the and decided to issue Final Show Cause Notice, Accordingly, a Final Show Cause Notice was issued to the institution on 04.12.2019. The institution vide letter dated 20.12.2019 has submitted reply to the Final Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 397th meeting held on 25th - 26th March 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 12.04.2021. The institution has submitted reply received on 16.04.2021.
- AND WHEREAS, the SRC in its 399th meeting held on 15th 16th June 2021 has considered the matter and the committee decided to issue last reminder letter. Accordingly, a last reminder letter was issued to the institution on 29.06.2021. The institution vide letter dated 01.07.2021 has submitted reply to the last reminder letter.
- AND WHEREAS, the SRC in its 400th meeting held on July 13th 14th, 2021 considered the 7. matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Last Reminder Letter. The institution has submitted its reply vide letter dated 01.07.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

 The NOC dated 08.09.2007 was issued by the Higher Education Department, Govt. of TamilNadu was issued with the condition to remove the High-Tension Voltage

The FDRs for Endowment and Reserve Fund is being maintained for one year only instead of five years as required under NCTE Regulations.

3. The building plan of the institution is neither approved nor legible.

4. Multipurpose Hall size is not sufficient.

5. The institution has not submitted latest staff list approved by the affiliating body for all the existing programmes.

Hence, the Committee decided to withdraw the recognition granted to Koviloor Andavar College of Physical Education and Sports Science, North Car Street, Koviloor – 630307, Near Karaikudi, Sivagangai District, Tamilnadu for conducting B.P.Ed. programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Koviloor Andavar College of Physical Education and Sports Science, North Car Street, Koviloor 630307, Near Karaikudi, Sivagangai District, Tamilnadu run by Sanathana Dharma World University Trust, sivagangai District, Tamilnadu for conducting B.P.Ed. programme of two years duration with an annual intake one basic unit of 100 students (two section of 50 students each) w.e.f. the next academic session i.e., 2021-2022 onwards.
- 9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
