**WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution **Shree Sharada Teacher Training Center, Panchamuki Ganapathi Colony, Tavarekere Hobli, Bangalore South Taluk, Bangalore District, Karnataka-562130** run by **Sharada Educational Trust, Bangalore District, Karnataka** vide SRC vide order no. F.SRO/NCTE/D.Ed./2006-2007/753 dt. 12.04.2007 for conducting Elementary (**D.Ed.**) course of two years duration with an annual intake of 50 students.

2. **AND WHEREAS**, the institution has submitted letter dt. 13.02.2020 for closing of the D.Ed. course.

3. **AND WHEREAS**, the SRC in its 400<sup>th</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> July, 2021 considered the matter and decided as follows: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -*

*The Committee agreed to close down the institution as requested by the institution vide dated 13.02.2020 by withdrawing the recognition granted to **Shree Sharada Teacher Training Center, panchamuki Ganapathi Colony, Tavarekere Hobli, Bangalore South Taluk, Bangalore District, Karnataka-562130** for conducting D.Ed. programme under clause 17(1) of NCTE Act, 1993 from the academic session 2020-2021.*

*However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:*

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course."

4. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Shree Sharada Teacher Training Center, Panchamuki Ganapathi Colony, Tavarekere Hobli, Bangalore South Taluk, Bangalore District, Karnataka-562130** run by **Sharada Educational Trust, Bangalore District, Karnataka** for conducting D.Ed. programme of two years duration with

an annual intake of 50 students (1 basic unit) w.e.f. the next academic session i.e., 2020-2021 onwards.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

***"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."***

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
