WHEREAS, the recognition was granted to the institution namely Akula Manikyam College of Education, D.No. 17-14-7, Ragiv Marg, Bypass Road, Tanuku, West Godavari District-534211. Andhra Pradesh run by Sri Gouthama Buddha Minorities Educational Society, Bye-pass Road, Pydiparru. D.No. 6-66, Tanuku, West. Godavari District, Andhra Pradesh vide SRC (NCTE) order No F.SRO/NCTE/B.Ed/2006-2007/4103 dated 14.06.2007 for conducting Secondary B.Ed. Course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, the SRC in its 294th meeting held on 14th -16th November 2015 considered the matter of the institution for ascertaining the compliance by the institution and decided to issue a Show Cause Notice to the institution for withdrawal of recognition. Accordingly, as per the decision a Show Cause Notice (SCN) dated 17.03.2016 was issued to the institution.
- 3. AND WHEREAS, thereafter, another Show Cause Notice was issued to the institution on 23.05.2018.
- **4. AND WHEREAS,** the SRC in its 400th Meeting held on 13th & 14th July, 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The committee observed that the institution did not submit affidavit for issuance of Provisional Revised Recognition Order for conducting B.Ed. course of two years' duration under NCTE Regulations, 2014 and the order was not issued. A Show Cause Notice dt. 17.03.2016 was also issued to the institution but the institution did not submit any reply.

Hence, the Committee decided to withdraw the recognition granted to Akula Manikyam College of Education, D.No. 17-14-7, Ragiv Marg, Bypass Road, Tanuku, West Godavari District-534211. Andhra Pradesh for conducting B.Ed. programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

5. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Akula Manikyam College

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
