- **4. AND WHEREAS,** the SRC in its 395th meeting held on 25th 26th February, 2021 considered the matter and decided as under:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the VT report that the inspection was conducted to the institution at its owned premise on 27.01.2021. The Committee decided that the Shifting of premises of the institution to its own new permanent building i.e. "Tirupathi Institute of Education, S. No. 203/6, 11, 21, 208/26, 41, Vootapalli, Merakamudidam Mandal, Vizianagaram District, Andhra Pradesh - 535102" hereby permitted.

The Committee also decided that after getting the affiliation process done the institution shall be required to submit latest staff list duly approved by the Andhra University.
