WHEREAS, the recognition u/s 14(3)(a) of NCTE Act,1993 was granted to the institution namely Sri Vidya Vihar College of Elementary Education, Khasara No.21part and 22/part, Plot No.6-1147/1, AP Annojiguda Village, Ghatkesar Post and Taluk, Rangareddi District-501301, Andhra Pradesh run by Rashtriya Vidya Kendra, Plot No.6-114/1, Near NTPC Circle Road, Annjiguda Education, Village, Gatkesar Post and Taluk, Gatkesar City, Rangareddi District-501301, Andhra Pradesh vide order no F. SRO/SRCAPP937/D.EI.Ed/AP /2015/66093 dated 31.05.2015 for conducting D.EI.Ed. Programme of two-years duration with an annual intake of 50 students.

- 2. AND WHEREAS, the SRC in its 413<sup>th</sup> meeting held on 22<sup>nd</sup> 23<sup>rd</sup> August 2022 discussed in detail about the institutions who failed to submit the PAR as advised by the NCTE. The Regional Director, SRC jurisdictional area and serve a Show Cause Notice for failure of submitting the PAR to all such institutions seeking infrastructural & instructional details along with GIS location etc. If any institution failed to respond to Show Cause Notice for compliance, after completion of given time, the RD, SRC may issue Final Show Cause Notice and place before the Committee for appropriate action. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 01.11.2022.
- 3. AND WHEREAS, the management of the institution has submitted letter dated 13.11.2022 with the request to close down the D.El.Ed. programme.
- 4. AND WHEREAS, the SRC in its 417<sup>th</sup> Meeting held on 1<sup>st</sup> & 2<sup>nd</sup> December 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

## The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution vide letter dated 13.11.2022 by withdrawing the recognition granted to Sri Vidya Vihar College of Elementary Education, Khasara No.21part and 22/part, Plot No.6-1147/1, AP Annojiguda Village, Ghatkesar Post and Taluk, Rangareddi District-501301, Telangana for conducting D.El.Ed. Programme under clause (7(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting."

- 5. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sri Vidya Vihar College of Elementary Education, Khasara No.21part and 22/part, Plot No.6-1147/1, AP Annojiguda Village, Ghatkesar Post and Taluk, Rangareddi District-501301, Telangana for conducting D.El.Ed. programme of two-year duration with an annual intake of 50 students from the academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn.
- 6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(6. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम की धारा 17(4) के निम्निलिखित प्रावधानों के बारे में सचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उददेश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
