WHEREAS, the recognition u/s 14 (3) (a) of NCTE Act, 1993 was granted to the institution namely Ayira Vaisya College of Education, No. 5/338, Sowkathali Street, Paramakudi, Ramanathapuram District, Tamilnadu-623707 run by Ayira Vaisya Sabai, Ramanathapuram District, Tamilnadu-623707 vide order No. F. SRO/NCTE /B.Ed./2008 /6150 dated 21.10.2008 for conducting (B.Ed.) Course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 19.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- **3. AND WHEREAS,** the SRC in 369<sup>th</sup> Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 16.09.2019. Thereafter, the institution has submitted reply of Show Cause Notice on 14.10.2019.
- **4. AND WHEREAS,** the SRC in its 401<sup>st</sup> Meeting held on 11<sup>th</sup>& 12<sup>th</sup>August, 2021 the matter was considered and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 31.08.2021. The institution did not submit any reply to Final Show Cause Notice.
- **5. AND WHEREAS,** the SRC 405<sup>th</sup> meeting held on 13<sup>th</sup>& 14<sup>th</sup> December 2021 considered the matter and decided to withdraw the recognition. Accordingly, a withdrawal order no F.SRO/NCTE/APS09441/B.Ed. /TN/2021/129712 dated 30.12.2021 was issued to the institution
- 6. AND WHEREAS, the institution has filed Writ Petition before Hon'ble High Court of Delhi bearing W.P (C) No. 9343/2022 titled as Ayira Vaisya College of Education Versus National Council for Teacher Education & Anr. Whereby the Hon'ble High Court has directed that: -

"Respondents are directed to update the status of Petitioner, within a period of one week from today, and send an intimation in respect thereof to the affiliating university of Petitioner as well as to the concerned Department of Education to

enable them to participate in the counselling and admission process for the academic session 2022-23.

Needless to say, Appellate Authority shall examine the merits of the case uninfluenced by any of the observations made hereinabove"

- 7. **AND WHEREAS,** aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-47/E-241084/2022 Appeal/7<sup>th</sup> Meeting, 2022 Appeal No.APPLSRC202214268 dated 19.10.2022 appeal remand back the order appealed against. The institution vide letter dated 21.10.2022 has submitted a reply to the Appeal remand back.
- 8. AND WHEREAS, the SRC in its 417<sup>th</sup> meeting held on 1<sup>st</sup> and 2<sup>nd</sup> December 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Ayira Vaisya College of Education, Survey No. T.S. No. 24, Block No. 18, Ward -H old S.No. 1/308, Sowkathali Street, Paramakudi, Ramanathapuram District, Tamilnadu-623707 for B.Ed. programme for 2 basic units of 50 students each."

- 9. NOW THEREFORE, this order is issued permitting the institution i.e. Ayira Vaisya College of Education, Survey No. T.S. No. 24, Block No. 18, Ward -H old S.No. 1/308, Sowkathali Street, Paramakudi, Ramanathapuram District, Tamilnadu-623707 run by Ayira Vaisya Sabai, Ramanathapuram District, Tamilnadu-623707 for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **10.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

- 11. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students:
  - f. Available infrastructural facilities:
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - i. The institution shall be free to post additional relevant information if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **13**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 14. The institution shall make available the list of students admitted on its official website.
- 15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
