ORDER

WHEREAS, the institution namely Mahatma Gandhi University College of Teacher Education, Vaikom, Kottayam District-686141, Keralawas granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed.2007-2008/13904 dt. 01.11.2007 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- **2. AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution by a notarized affidavit dt. 17.06.2015 consented to come under new Regulations.
- 3. AND WHEREAS, the Southern Regional Committee (NCTE) issued the Revised Provisional Recognition order dt.09.07.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (one basic units) from the academic session 2015-2016 subject to fulfilment of conditions mentioned therein.
- AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 4. and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 17.07.2019. The institution submitted its reply on 09.10.2019. The matter was considered by the SRC in its 383rd meeting held on January 7-9. committee decided 2020and. the issued Final Show Notice. Accordingly, as per decision of SRC a Final Show Cause Notice issued to the institution on 20.01.2020. The institution submitted its reply on 14.02.2020 & 10.02.2020. The matter was further considered by the SRC in its 387th meeting held on 24th -25th August 2020 and the Committee decided to issue last reminder letter. Last reminder letter issue to the institution on 19.10.2020. The institution has submitted reply to letter on 27.11.2020,30.12.2020 & 20.01.2021.

5. **AND WHEREAS**, the matter was further considered by the SRC in its **394**thmeeting held on **27**th **-28**th**January 2021** and the Committee decided as under: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Mahatma Gandhi University College of Teacher Education, Vaikom, Kottayam District 686141, Kerala for B.Ed programme for 1 basic unit of 50 students.

- 6. NOW THEREFORE, this order is issued permitting the institutioncontinuation of conductingMahatma Gandhi University College of Teacher Education, Vaikom, Kottayam District-686141, (Survey No. 199/10/A-B) Kerala runby Mahatma Gandhi University for B.Ed. course of two years duration with an intake of 50 students (one basic units) subject to fulfilment of the following conditions:
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **7.** Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

- 8. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
 - 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
 - **11.** The institution shall make available the list of students admitted on its official website.

12. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
