WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Sidhartha College of Education, No. 1, Chowdiah Black, R.T. Nagar, Bangalore – 560032, Karnataka vide order no. F.SRO/NCTE/B.Ed./2004-2005/8920 dt. 30.11.2004 for Secondary (B.Ed.) course of one year from the academic session 2004-2005 with an annual intake of 100 students.

2. AND WHEREAS, the SRC in its 294th meeting held on 14th-16th November,2015 and the committee considered the matter and notice that the institution has not submitted affidavit adhering to Regulations 2014 and hence not issued Revised Orders and decided to issue Show Cause Notice for withdrawal of recognition under NCTE act for the following deficiency.

Affidavit not submitted affirming adherence to Regulations, 2014

- 3. AND WHEREAS, the SRC in its 294th Meeting held on 14th -16th November, 2015 had considered the matter and decided to Withdraw the recognition. Accordingly, as per the decision of SRC, Withdrawal Order vide no. F.SRO/APSO2084/B.Ed./KA/2018-19/97420 dt. 23.05.2018 was issued to the institution.
- **4. AND WHEREAS,** the institution had filed a WP. No. 26059 of 2023 in the Hon'ble High Court of Karnataka, Bengaluru Bench, whereby the Hon'ble High Court vide its order dt. 03.06.2024 has directed that:
 - "8. Accordingly, petition is allowed. The order in appeal at Annexure-'E' is set aside. The matter is remitted back for fresh consideration. The Petitioner is permitted to produce necessary documents if not available on file with Appellant Authority regarding the affidavit, copy of which is produced in the writ proceedings at Annexure 'F' as well as make out a reply to the show cause notice as referred to at sub paragraph (ii) referred to above".
- 5. **AND WHEREAS**, the SRC in its 439th meeting held on 14th June, 2024 considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 30.07.2024. The institution has submitted reply on 02.08.2024.
- 6. AND WHEREAS, the SRC in its 441st Meeting held on 04th August, 2024 has considered the matter and decided as follows: -

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following decisions:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Infinity Ashwini Samhitha (I.A.S) College of Education, No. 1, 1st Cross, Chowdiah Block, R.T. Nagar, Bangalore-560032, Karnataka for B.Ed. programme 2 basic units of 50 students each."

- 7. NOW THEREFORE, this order is issued permitting the institution i.e., Infinity Ashwini Samhitha (I.A.S) College of Education, No. 1, 1st Cross, Chowdiah Block, R.T. Nagar, Bangalore-560032, Karnataka for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 9. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.

- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 12. The institution shall make available the list of students admitted on its official website.
- 13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
